1) To provide, erect and maintain all necessary barricades, lights, warning signs and other devices to safeguard traffic properly while the work is in progress.

- 2) That the road will, at no time, be closed to traffic.
- 3) Where the drive is located in curb, curb and gutter, and/or sidewalk section, the owner will completely remove the existing curb, curb and gutter, and/or sidewalk and replace it with a standard concrete or granite driveway terminal section .
- 4) In all cases to notify the Sandy River Town Office at least 24 hours before starting work on the driveway. Office hours are Monday Friday, 8am to 4pm.
- 5) To construct and maintain said driveway approach in accordance with D.E.P. or L.U.P.C. , "Rules and Regulations ".

FURTHER CONDITION OF THE PERMIT: shall be that the owner shall well and truly pay all damages, fines, and penalties for which he shall become liable, and shall indemnify and save harmless said Sandy River Plt. against all suits, claims, damages and proceedings of every kind arising out of the construction and maintenance of said driveway approach, including snow removal.
