- 5) To construct and maintain said driveway approach in accordance with D.E.P. or L.U.P.C. , "Rules and Regulations ".

**FURTHER CONDITION OF THE PERMIT:** shall be that the owner shall well and truly pay all damages, fines, and penalties for which he shall become liable, and shall indemnify and save harmless said Sandy River Plt. against all suits, claims, damages and proceedings of every kind arising out of the construction and maintenance of said driveway approach, including snow removal.
