To: Ryan H. Thompson, A Constable in Sandy River Plantation, in said County of Franklin, State of Maine.

GREETINGS: In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of Sandy River Plantation, in said County and State, qualified to vote in Town affairs, to assemble at the **Sandy River Plantation Town Office** in said Plantation on **Tuesday, October 22, 2024 A.D. at 4:00 p.m.** in the evening, then and there to act upon Articles A1 through Articles ORD1 of this warrant.

ARTICLE A1: To choose a moderator to preside at said meeting.

ARTICLE A2: To see if the Plantation will vote to change the term of office of the Board of Assessors from one year to three-year terms, to be implemented at the 2025 annual meeting, with the election in 2025 of one Assessor for a three-year term, one Assessor for a two-year term, and one Assessor for a one-year term, and thereafter, upon expiration of these initial terms, Assessors shall be elected for three-year terms.

ARTICLE A3: To see if the Plantation will vote to change the office of Clerk from an elected office to an appointed office, with a term of three years, to be appointed by the Assessors, said change to take effect at the 2025 annual meeting.

ARTICLE A4: To see if the Plantation will vote to change the office of Tax Collector from an elected office to an appointed office, with a term of three years, to be appointed by the Assessors, said change to take effect at the 2025 annual meeting.

ARTICLE A5: To see if the Plantation will vote to change the office of Treasurer from an elected office to an appointed office, with a term of three years, to be appointed by the Assessors, said change to take effect at the 2025 annual meeting.
