Indian Notch Park

The Town of Bolton is accepting proposals for vehicle ice cream vending at Indian Notch Park. The operator of this concession must adhere to the guidelines and boundaries set up in this agreement: Deadline for request is **Monday, June 24, 2024 at 10 a.m.**

1. ***(There will be NO REFUNDS of bid/proposal amounts due to COVID-19 Restrictions or Guidelines and/or due to the closing of the Lake due to the health of the lake water).***
2. The vendor can operate this mobile concession June 22, 2024 until the lake closes for the season.
3. Vendor must follow all town health and vending rules/ordinances.
4. This concession is limited to ice cream and non alcoholic beverage sales.
5. The vendor will have the privilege to park their vehicle at Indian Notch Park as designated by staff.
6. The operator will continue to maintain their vending and health license & certificate of insurance current with the Town of Bolton and its agencies. A copy will be kept on file in the Town Administration office.
7. The operator and the areas of vending will be evaluated by the Town of Bolton Resident State Troopers and Town staff.
8. Indian Notch Park is open 9a.m. to 5p.m. Monday through Sunday, weather permitting.
9. The vendor's vehicle is allowed to drive through the pathways in the park as determined by staff.
10. The Town shall be held harmless from any liabilities associated with the vendor and/or their partners.
11. The vendor shall keep areas clean of any debris generated by their operation.
12. The vendor cannot dump trash generated from the concessions into any Town/Park receptacles.
13. This permit is only for Indian Notch Park.
14. The Town of Bolton reserves the right to terminate this agreement if areas of the agreement are breached.
15. All employees working in park areas must have their name, address, and phone number provided to the Town in advance. This information will be kept in the vendor's file.
16. The Town of Bolton reserves the right to perform background checks on any vendors using the park for business.
17. The Town of Bolton reserves the right to reject any or all applicants at its sole discretion if deemed to be in the best interest of the Town of Bolton.
18. Vendor represents that they are an equal opportunity employer, and will not discriminate with regards to race, religion, color, national origin, age or sex in the performance of this contract agreement.
