# Heritage Farm Commission Special Meeting July 10, 2017

The Bolton Heritage Farm Commission held a special meeting on July 10, 2017 at the Bolton Heritage Farm. Members in attendance were Chairman Sandra Pierog, Arlene Fiano, Beth Harney and Kathy Aspinall. Building and grounds supervisor John Butrymovich was also present. Ann Maulucci was not present. Alternate Bonnie Massey and Richard Treat were also present.

#### 1. Call to order

Sandra called the meeting to order at 7:02 P.M.

# 2. Approval of Minutes of April 3<sup>rd</sup> and June 5<sup>th</sup> 2017 Meetings

Kathy Aspinall made a motion to approve the April 3, 2017 minutes with the above corrections; Arlene Fiano seconded the motion. The motion passed. Kathy Aspinall made a motion to approve the June 5, 2017 minutes with the above corrections; Arlene Fiano seconded the motion. The motion passed. Beth Harney abstained from both motions.

#### 3. Unfinished Business

#### A. Farm maintenance and repair projects

Sandra informed the Commission that Raymond Marrion from Leonard Giglio/Rockland Farms contacted her. Raymond asked Sandra to add haying issues to the agenda. Raymond could not make the meeting so Richard Treat spoke on Raymond's behalf and asked the Commission for permission to remove rocks that are on the surface where they are haying. Richard explained they would remove the rocks and could take them when finished. Sandra stated they could remove the surface rocks where the haying is taking place but to leave the rocks on the property and move the rocks by the house along the pine tree line. Sandra also told Richard to have Raymond get in contact with John Butrymovich. Richard Treat also asked the Commission if the test holes out in the field that were drilled could be removed because it is in the middle of the field. Sandra told Richard she would speak with the First Selectmen at the next meeting. Richard Treat asked if the some branches by the pine trees could be trimmed back. John stated he would take a look

Arlene Fiano asked the Commission about Leonard Giglio's contract with the town and what was going to happen with the Haying. John Butrymovich stated that Lenny Giglio sent a letter to the town saying he wanted to take over the haying. Sandra stated she would ask the First Selectmen at the next meeting. Sandra reiterated to Richard Treat that Raymond has permission to remove the rocks and place near the pine trees, and she will get back to Raymond about the test holes and trimming the tress. John Butrymovich stated the cross country path has been cut and that the tree on the corner of the driveway was taken down. John also informed the Commission that the pieces of installation hanging from the rafters in the shed have been removed. The security company is coming at the end of the week to give an estimate to bring the barn up to code.

Sandra stated the final inspection was done on the fire repairs.
