REGULAR MEETING NOVEMBER 24, 2025

BOLTON FIRE HOUSE AND ZOOM- 7:00 P.M.

Fire Commission Chairman John Morianos convened the Bolton Fire Commission meeting at 7:00 P.M. at the Bolton Fire House.

Commission members present: Chris Moquin. Danny Moquin was on zoom call. Chief Dixon also attended via Zoom call. Deputy Chief Matthew Perreira and Fire Marshal Bill Call were also present. Elizabeth Malone and Robert Langton were absent.

CORRESPONDENCE – None

APPROVAL OF MINUTES – Motion to approve the October 27, 2025 meeting minutes (CM/DM).

PAYMENT OF BILLS – October and November were distributed

COMMUNICATION FROM THE CHIEF –

- 39 calls since the last meeting
- 4 motor vehicle accidents 2 of which were on Route 6 and on I-384
- Brush fire – nothing found on Route 44
- Many EMS calls, including one CPR call
- Budgets: Capital Improvement Projects have been submitted to the Town Hall. Gear washer and dryer and radio tower restoration. Mobile radios are on order and scheduled for spring 2026 for front line apparatus.
- E hydraulic tools are being researched, and Chief Dixon hopes to have a decision in January 2026. Dry hydrant information has been looked at by senior fire officers and a letter has been sent to the town Administrator.
- Operation Budget is on target with spending at this time.
- Training: One Officer passed his Fire Officer One and Accelerated Paramedic Program 2 class and two members passed their State of CT Department of Motor Vehicle Q class.

Chris Moquin asked Chief Dixon where the waste water goes from the washing machine. Chief Dixon replied that it goes into the septic at the fire house.
