RE: 250 Carter St. Solar Farm Proposal

I am speaking on behalf of concerned residents of Bolton regarding the proposed installation of a solar photovoltaic electric generating facility (Solar Farm) at 250 Carter Street.

This initiative, as presented by TriTec, a California-based company, has raised significant apprehensions within our community, particularly in light of the numerous negative impacts we expect, ranging from decreased property values, health and safety, water management, to the environment, wildlife and destruction of natural habitat.

As the Board of Selectmen, we are asking for your assistance with the following:

 To submit formal testimony via email in opposition to Petition NO. 1609 to the CT Siting Council and request a public hearing by March 7th. - It is imperative that our voices are heard, and a thorough examination of the environmental and community impacts is conducted.

Why you should be concerned:

- Local Approval Not Needed: A Solar developer just needs to file an application with the CT Siting Council. The Siting Council has exclusive jurisdiction over this type of project. This can happen anywhere in town or anywhere in the state. Your back yard could be next.
- Bolton Residential Impact: This proposed solar farm is located next to the Bolton Town
 line and residents would be affected by the noise and any adverse effects of the solar
 farm.
- First Responder Support: may be needed if there is a fire.

Let me highlight some of the specific concerns raised by Manchester residents regarding the proposed industrial solar farm project.

 Property Values: Studies have shown that nearby solar farms can negatively impact residential property values, leading to decreased property assessments and lower

- property tax revenue for towns. This area of town is zoned rural-residential to prevent industrial and commercial encroachment
- Environmental Impact: The construction of the solar farm will result in
 deforestation, habitat destruction, and contamination of wetlands This poses a
 significant threat to local ecosystems and biodiversity. The proximity to the Shenipsit
 Hiking Trail, a cherished recreational resource that traverses' conservation lands
 protected by the Kongscut Land Trust and the Manchester Land Trust, is at odds with
 industrial development.
- Endangered Species: The project further endangers multiple species of concern, including the Eastern Box Turtle and Long-Eared Bat, as identified by the Department of Energy and Environmental Protection (DEEP).
- Water Management: Inadequate stormwater management measures will compound
 the erosion and water runoff that occurs when land is deforested It will threaten
 downslope properties with higher flooding risks than exist today and escalate
 environmental degradation of the entire community.
- Safety and Health Concerns: Residents are concerned about potential noise
 pollution, fire risks associated with industrial solar farm electric generating facilities usually started by inverters or other equipment malfunctions or failure. The
 proximity of the solar farm to the Algonquin pipeline: which transports about 20
 billion cubic meters of natural gas per year, seems ill-advised.

Property Values – A decrease in residential property values would decrease our property assessment in turn lower the towns' property tax revenue.

<u>Solar's Impact on Rural Property Values (asfmra.org)</u> A 2021 study from the University of Rhode Island looked at 400,000 transactions in New England over the course of 15 years, finding that suburban residential property values suffered negative impacts when nearby solar farms replaced resources perceived as scarce, such as green space.

What Is a Safe Distance to Live from a Solar Farm? — Climate Cafes There were a number of other studies completed with the same negative impacts. For instance, it could have an aesthetic impact on your neighborhood.
