Tax Collector Salary Comparisons

Purpose:

This document serves as a write-up to compare the wages of the Town's Tax Collector to other supervisory positions as well as other town tax collectors.

Methodology:

- 1. Receive assignment including the towns that require comparison.
- 2. Outline Excel tables to display data.
- 3. Research and record Bolton supervisory salaries for comparison.
- 4. Reach out to selected towns to determine the data required for comparisons.
- 5. Summarize data and findings.

Findings:

- Compared to town supervisory positions, the Tax Collector is paid 16.08% below the average salary for FY25. If the proposed FY26 raise is enacted, the Tax Collector will be paid 12.40% below the average.
- The raise request is a 7.20% request while the average request is 2.80%.

Important Notes:

- Some towns have part-time tax collectors (Sprague) and have been noted as such.
 Scotland was excluded from this data even though it was requested because
 Scotland uses the Town of Windham's Tax Collector.
- This information is merely informative of the information requested by the Town administration, it is not a policy recommendation.

Purpose:

This document serves as a write-up to compare the wages of various employees of the Registrar of Voters across nearby towns in Connecticut.

Methodology:

- 1. Receive assignment including the towns that require comparison.
- 2. Outline Excel tables to display data.
- 3. Reach out to selected towns to determine the data required for comparisons.
- 4. Summarize data and findings.

Findings:

- The Town is currently above average in terms of its pay of Assistant Registrar and Data Entry Clerk.
- The Town is currently below average in terms of its pay of its Registrar, Deputy Registrar, Moderators, and Election Workers.
- The Proposed Bolton line would put the town above average in pay for all positions except for Election Workers and Moderators.
- See Table 1 for general pay information. See Table 2 for percent above/below average pay for the current rates of pay and the proposed rates of pay.
- Please see the additional information sheet for further details on pay in the requested towns.

Important Notes:

- Data used in averages and Tables 2 and 3 include only the hourly paid positions.
 Salaried employees are not included in these calculations.
- This information is merely informative of the information requested by the Town administration, it is not a policy recommendation on whether wage increases should be enacted for the Town of Bolton Registrar of Voters.
- Some towns pay their workers on a salaried basis as opposed to an hourly one.
 These towns have been listed separately in Table 1.1 to avoid skewing the average hourly data.




Chart 3 is a visual representation of Table 3 with the addition of the averages so that it is easy to compare to the current and proposed Bolton wages.

Additional Information:

Ashford: Registrars of Voters and Deputy Registrars of Voters are paid \$30 for all activities they do. That includes the days that they are at Conference, from the time that they leave the town hall until they return to the town hall. If they stay overnight, which we do, they get paid from the time the classes start until they end. They get paid to go to county meetings which are required as part of their training. They also get paid for participating in the various committees that ROVAC has. They only need to go to one so they can report back to their county on what the committee is working on. Most committees do not meet monthly.

Moderators get paid \$24 an hour no matter which position they serve in. We do that so we don't lose good, qualified Moderators, which are hard to come by.

All other poll workers are paid \$19.12 an hour which includes mandatory training sessions for every election. Primary and Budget Referenda. In addition, they are provided with coffee and water throughout the day and lunch. We usually have them order a full grinder, so they have food for dinner. They are granted paid time for lunch but there is no guarantee that they will have time for dinner.

Hebron: Registrars earn \$11,000 annually. Deputy registrar 6,900 annually Poll workers, checkers and election workers can make between minimum wage to \$25 per hour.

Scotland: No Response

Sprague: Registrar of Voters - \$19.00

Moderators - \$17.00 The rest \$16.35

Willington: Willington's Election Officials pay rates. Registrars are salaried: \$15,375 annually, Early Voting Stipends: Primary \$2,000, Election \$4,000. Deputy Registrars are hourly: \$18. Election Officials are paid a per diem rate for voting events: Assistant Registrars: \$335 per diem, \$18.50 for audits, recounts, etc. Moderator: \$450 per diem, \$22.00 for audits, recounts, etc. Checkers, Ballot Clerks, Tabulator Tenders: \$306 per diem, \$17.50 for audits, recounts, etc.
