7. Wetlands Agent Report

Staff provided the following updates:

- Rod Parly contacted DEEP about the IWC forestry ruling on Box Mountain. The DEEP State Forester replied supporting and affirming the ruling; Staff received a copy of the correspondence.
- Inspection has taken place at the Valero Station where the concern was for storm water reinforcement on the bank. Rip rap was not used, but the material that was used is as effective.
- Notice has been received about Tinker Pond being treated for aquatic weeds.
- 37 Notch Road A follow up visit to Mr. Ouzounov was made about the extent of the wood chips that were laid. Some part of those will be pulled back by the time Staff visits in a month.
- 1120 Boston Turnpike the issue with the basin is ongoing. The owners talk about doing the necessary work or wanting to alter what was approved on the site plan, but no work is taking place. Bolton Lake Brook runs along the property which takes discharge from all of the Bolton Lakes. The bond was posted a year ago. If nothing happens soon Staff will send a forceful letter. Lally suggested that if there is no movement the owners should be asked to appear at the August IWC meeting to explain why this is an issue. Since the permit remains open the Members have the right to go onto the property and inspect the area. Lally will do so and he urged the other Members to visit also.
