A. Jurisdictional Ruling for Timber Harvest – Chris Casadei – 122 Route 6, Andover, CT 06232

Staff said that Chris Casadei is with Hull Forest Products. This item is before the IWC to determine if falls under Bolton IWC regulations Section 4.1a. Staff said maps of the area and the notification of the intended forest harvest on the Andover Sports Club property were included in the Members packet. There are two parcels in Bolton and one in Andover. Staff walked the site and examined the area with

Casadei. The Bolton Land Trust has property surrounding the area. The piece has been regularly managed over the years. The haul roads are in place. The roads are in good, stable condition. There is one wetland crossing in Bolton. This is coming down a fairly steep, rocky hill. The intent is to reinforce the road by putting down logs to create a corduroy road. There will be some timber harvested in the wetlands on the edge of the watercourse to grab diseased ash trees. All markings were indicated at the time of Staff's walk through. Large healthy trees will remain to produce seed. This is clearly an agricultural activity.

The entrance road to the Club will be used to take equipment in to and out of. None of the proposed activities require a permit and there is to be no building of structures. The one wetlands crossing is the IWC's concern. They are maintaining a healthy forest through this management and stewardship of the property. This is not in preparation for development as we have seen in the past. The Club has an interest to maintain their diverse habitat.

Staff was comfortable with the forester's plan and that plan translated well to the people who have started the work in Andover.

7. Wetlands Agent Report

Staff had attended a Zoom meeting was held with a group from UConn along with Patrice Carson, Jim Rupert, and Josh Kelly. A UConn student is doing some LID study work and will be looking at Town properties to see where some low storm water impacts can be used. The other town UConn is looking at is Windsor Locks. The focus will be provide visible education of LID impacts.

Staff visits the properties for all applications that come in.

Sandy Pierog said the property across from the high school is owned by the Brundola family. The family is very much aware of the wetlands that are there. In response to talk that a solar farm is going there the Bolton zoning regulations would need to be changed to allow that. Developers identified three properties for possible solar farms but backed down when they found out this is not an as-of-right activity. Any developer would have to apply for a zoning change and would not be exempt from property taxes.

Pierog also said the PZC hearing for 1 Notch Road was postponed until the November meeting after a local group hired an attorney.

The court case for 65 Shoddy Mill Road continues to be worked on.
