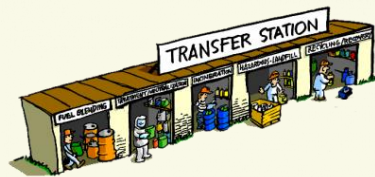
SCRAP METAL - APRIL 28 TO MAY 02, 2025

Items for collection must be curbside by Sunday Night, April 27.



Curbside scrap metal collection will be held the week of April 28- May 02, 2025. Items for collection must be curbside by Sunday Night, April 27. Noncombustible items such as appliances and other metal items weighing up to 100 pounds are acceptable. Gas grill propane tanks need to have the caps removed. Unacceptable items include motor vehicle parts, machinery, and items weighing more than 100 pounds. Please remember this collection is for scrap metal only, not for bulk waste.

Please note that all acceptable scrap metals will be picked up by Friday afternoon. If your items are not picked up by 4 pm on Friday, then you are responsible for getting rid of the items. Any items not picked up can be brought to the transfer station during their scheduled open times. (You will need to purchase a transfer station ticket if this occurs.)

Performs work in the maintenance, repair, and construction of parks, grounds, recreational areas, and facilities, including custodial and maintenance duties. Pay rate is \$16.35/ hour. LIFEGUARD (SEASONAL)

The Bolton Recreation Department is seeking both full time and part-time seasonal summer lifeguards. Under the direct supervision of the head lifeguard, lifeguards are responsible for the everyday safety and well-being of patrons at Indian Notch Lake. Lifeguards will strictly enforce all policies, procedures and regulations with all patrons. Staff will work closely with other town staff daily and perform all rescues and follow-up procedures. Lifeguards must have their Lifeguard certificate through the Red Cross, **including waterfront**. Please check the Red Cross website for dates, times, and locations to become certified.

UPDATE ON NOTCH ROAD MUNICIPAL CENTER DEMOLITION

As you may be aware demolition operations began after abatement work was completed and then came to a halt. This occurred because there was an issue with the disposal of the concrete from the foundation. Our environmental consultant and demolition contractor worked together to resolve the issue. Ultimately, they ended up sandblasting the paint from the interior surfaces of the concrete as a solution. That process is still ongoing, but active demolition should resume on or near May 20. Active demolition is scheduled to be completed around June 11. After the demolition is completed, there will be a couple of weeks of site restoration. There is also some work being done on the portion of the building that remains. The project is scheduled to wrap up during the first or second week of July.
