SNOW REMINDERS (INCLUDING DAMAGED MAILBOXES)

Please check the stability of your mailbox and pole. The town will not be responsible for damage to mailboxes as the result of the weight of snow hitting the box or post. In the event that a Bolton snowplow makes contact with a mailbox and damages it, the town will replace the mailbox with a standard U.S. Postal Mailbox (cost approximately \$20) in addition to a 4"x 4" post and installation. If we damage your mailbox, please call the selectmen's office to report it within two business days after the incident. The highway supervisor will be responsible for determining the cause of any damage to a mailbox. Residents who are not willing to accept the standard U.S. Postal Mailbox as a replacement will be offered a check for the cost of a standard U.S. mailbox only. The town will not be responsible for incurring the cost of specialty mailboxes.

During snowstorms, residents are asked to help the highway crew keep our roads clear by not parking cars or placing trash cans in the road. In addition, snow from resident's driveways should not be plowed onto town roads. This can create hazardous conditions for everybody. As such, there is a Town ordinance with a fine that prohibits property owners from plowing snow into the road.



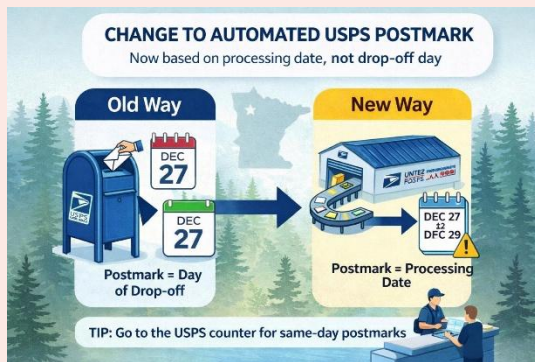

FROM THE TAX COLLECTOR'S OFFICE

SUPPLEMENTAL MOTOR VEHICLE TAX BILLS

A small number of Supplemental Motor Vehicle bills were mailed out at the end of December and must be paid by February 2, 2026, to avoid interest. The tax bills are for motor vehicles that were newly registered either in August or September 2025. If you have a vehicle that was registered in that time frame and did not receive a bill, please call my office at 860-649-8066 x6101. Failure to receive a bill does not invalidate the tax and/or interest.



USPS POSTMARK CHANGES

USPS recently changed their procedures in which your mail may not be postmarked the same day it is mailed. Being that this office **must** use a U.S. postmark for interest purposes please make sure if you are mailing your tax bill close to the last day, that you go to the post office to get a hand stamped same day postmark to

make sure that the date of mailing is the date on your envelope.

USING YOUR BANKS BILL PAY

When you use your banks bill pay to make a tax payment, please be aware that the payment is sent by check and mailed using an envelope that is NOT postmarked. If your payment is received after the delinquent date, interest will be added to your account. The guaranteed delivery date from your bank is not the same as a us postmark and will not be used as such. If you pay in this way please mail your payment to Tax Collector, 222 Bolton Center Rd. Bolton CT 06043 and give ample time for the bank to process the check and mail it so it is received before the delinquent date or use another means of payment such as our online payment portal shown below.

Please use the link above if you need a receipt of tax payments made in 2025. When searching for your accounts and look up by name, enter your Last Name, then space, then 1st Initial (example SMITH J) or Business Name (No comma). Do this for every household member to make sure you don't miss any accounts.

-Once you put in your name, check the
"IRS Payment Records for Year 2025."

-Check all account you want to include in your report
and then click "VIEW IRS."

-Left-click on the screen and choose print to print your records.

NOTICE: ELDERLY AND TOTALLY DISABLED HOMEOWNER'S EXEMPTION PROGRAM

Applications for the Elderly and Totally Disabled Homeowners tax relief program will be accepted in the Assessor's Office between February 2 and May 15, 2026. The program provides a tax credit on the July 2026 tax bill ranging from \$150 - \$1,250.

The State of Connecticut Program, and a matching local program, are available to residents of Bolton who:

- Have attained the age of 65 on or before December 31, 2025, or who are totally disabled according to Social Security guidelines.
- Were Bolton residents and owned their home on October 1, 2025. Only a primary residence is eligible for the program. A primary residence is defined as residency for a minimum of 6 months plus one day in a program year.

- Had a total income not exceeding \$46,300 for a single person or \$56,500 for a married couple in the 2025 calendar year. Income includes taxable as well as nontaxable income.

Persons already enrolled in the program and up for renewal will be mailed reminders that they must refile.

Applications can be filed at the Assessor's Office, Town Hall, 222 Bolton Center Rd., during Town Hall hours. Applications may also be mailed to the Assessor's Office as long as it is received by April 15, 2026. From April 15 - May 15, 2026, all applications must be made in person, preferably by appointment, at 860-649-8066 ext. 6100.

Proof of income, including Social Security 1099 forms, are required. If an income tax return is filed or to be filed for 2025, a copy must be included. If applicable, proof of disability is also required at the time of filing.

Income based programs allowing increased exemption benefits are also available to veterans; applications can be taken at the same time as the elderly relief program.

NOTE: The Town of Bolton has a local option program for the deferral of property taxes for eligible persons. This program allows an eligible person to "freeze" their property taxes at last year's amount, but income (married must be less than \$75,000; single must be less than \$50,000) and age (over 70 years of age) limits apply, and a lien is placed in the land records on the property by the Town in the amount of the abated taxes.

LEGAL NOTICE BOARD OF ASSESSMENT APPEALS TOWN OF BOLTON

Property owners and lessees have the right under Connecticut General Statutes, Sections 12-110, 12-111 and 12-504d to appeal the assessment of motor vehicles, personal property and real estate on the 2025 Grand List. CGS §12-117 requires written appeals to be received by the Board of Assessment Appeals at Town Hall on or before 1:00 pm, Friday, February 20, 2026. Appellants will be notified of the time and date in March 2026 when the BAA will hear their appeal. The BAA is scheduled to meet in the Bolton Town Hall on March 10, 2026, with additional dates in March if needed.

The appeal form must contain the following information: the property owner's name; name and position of the signer; description of the property that is the subject of the appeal; name and mailing address of the party to be sent all correspondence by the BAA, reason for the appeal, appellant's estimate of value and dated signature of the property owner or duly authorized agent of the property owner.

If any of these items are not provided, the Board can decide not to hear an appeal.

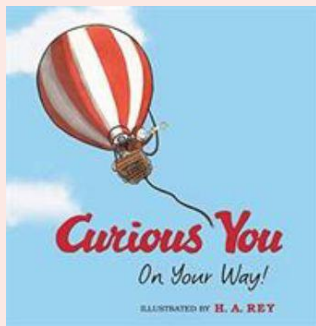

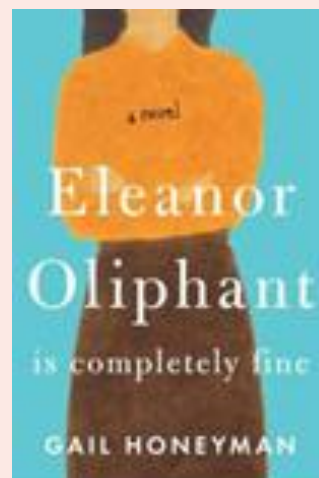
