### FROM THE TAX COLLECTOR OFFICE

**Property Tax Bills:** Tax Bills will be mailed out by the end of July AND will be available soon to be viewed and paid online. These bills will be due August 1, 2025, and must be paid by or postmarked by September 2, 2025, to avoid interest. Interest accrues at 1.5% from the due date of August 1<sup>st</sup>, for a total of 18% per year. Please be aware that if paid late the interest rate is 3% from September 3-30<sup>th</sup>. Minimum interest is \$2.00 per bill.

The tax bills will be based on a temporary rate of 31 mills that was set by the Finance Committee on 7-16-25.

#### What if I do not receive a tax bill?

Not receiving a tax bill does not invalidate the tax and/or interest. If you do not receive a tax bill you can check online and print it out with the above link and/or call our office if you still do not find it.

<u>Motor Vehicle Accounts:</u> Please make sure to check your car registration to make sure it is still active, which could be the reason why you did not receive a tax bill. If there is a lapse in your registration, please call the Assessor's office. They can add it on to the tax rolls once your registration has been renewed to avoid multiple tax bills being due at a later point.

**<u>Real Estate Accounts:</u>** If you recently paid off your mortgage, switched mortgage companies or now pay your own taxes, and you did not receive your tax bill please either use the link above to find your account or call our office to get a copy of your tax bill.

If you receive a bill that your mortgage holder is supposed to pay, please call and forward the bill to the mortgage holder so they have time to process and send the payment.
