- 3) Presentation from North Suffolk re: supportive housing
 - a) Tim Gray from North Suffolk gave a presentation re a project at 131
 Hitchborn Ave replacing a 5-person group home with a larger duplex unit providing 9 units of supportive/affordable housing
 - b) The project currently has a \$300,000 funding gap which will need to be financed if alternate sources not found; the hope is for AHTF to provide some level of support
 - c) Dean Harris suggested (and the board generally agreed) that the AHTF should determine what percentage of its budget should go to these types of projects and create an application/RFP process. This will be added to the next meeting's agenda.
 - d) Joe Gravellese ensured Mr. Gray that we would keep in touch about his proposal and if we open up application for a round of funding to support this type of project.
