- 1) Call to order & roll call of members

- Finances check-in
 - a) Treasurer Osueke reported that the most up to date amount in the fund is \$907,940.43
- 3) Membership matters
 - a) The AHTF voted unanimously to appoint Matt Wolfer as vice-chair, replacing the departed Claire Inzerillo
 - b) We have a potential new pending member, Judy Gosselin, pending to appear before an upcoming City Council meeting. The AHTF expressed its support for Judy and hope for speedy confirmation by the council.
- 4) Acquisition of deed-restricted properties
 - a) After a meeting with support from MHP, we reviewed the possibility of acquiring deed-restricted properties and it was determined that a better course of action would be to instead support potential sellers in their sale process - helping them market the property, find potential owners, help with screening eligibility, etc.
 - b) The DPCD will reach out to owners of such properties to offer this assistance
- Proposed alterations to First-Time Homebuyer Downpayment Assistance Program
 - a) The AHTF voted unanimously to change the eligibility guidelines for the first-time homebuyer downpayment assistance program, changing the income limit from 80% AMI to 100% AMI effective

immediately. This is in light of the fact that the program has been open at 80% AMI for ~8 months but there are still several grants available/funds unused.

 - a) The AHTF reviewed the "Wellfleet model" and determined that this type of program a loan program for ADU conversion in exchange for rental affordability is something we should model.
