# Traffic Commission Agenda September 23, 2021

Notice is hereby given in accordance with the provisions of Chapter 185 of the Acts of 1983, and Chapter 13 of the Acts of 1984, that the City of Revere Traffic Commission will conduct a Public Hearing on September 23,2021 at 5:00 p.m. in the City Councilor Joseph A. Del Grosso Council Chambers of Revere City Hall relative to the following proposed amendments to the parking and traffic regulations of the City of Revere:

1. Various amendments to the following streets located on Riverside: Archer, Lawson, Wadleigh, Gilbert, Frank, Beckert, Tobin, John, River, Thayer, and Hayes Avenues.

Section 1. Schedule VIII of Title 10 Parking Restrictions Generally is hereby amended by removing the no parking on both sides restriction for all streets on the Riverside, excluding Mills Avenue, and provide for parking on one side of those streets. The side of the streets to be designated as "no parking" will be determined by the Traffic Commission.

Section 2. Schedule IX of Title 10 – Resident Parking Streets – Twenty-Four Hour Enforcement is hereby amended by adding all streets on the Riverside, excluding Mills Avenue. The side of the streets to be designated as "24/7 Resident Parking" will be determined by the Traffic Commission.

 The residents of 420 Revere Beach Blvd wish to continue the Public Hearing from the last Traffic Commission Meeting. The residents are seeking to be resolve issues with regards to permits, visitor passes and caregiver passes.

### **Requests:**

- 1. Councilor McKenna request that the Traffic Commission Amend Schedule IX of Title 10-Resident Parking Streets- Twenty-Four Hour Enforcement by adding:
- a. Cross Street entire length
  - 2. That the Mayor request the Traffic Commission to designate four (4) 24-hour resident only parking spaces in the Central Avenue Municipal Parking Lot for the residents of Aucella Court and Central Avenue Rear. The Traffic Commission overlooked the residents living on these streets when metered parking was established in the Central Avenue Municipal Parking Lot.
  - 3. That the Mayor request the Traffic Commission to install "Stop" signs, facing both directions, on Rice Avenue at the intersections of Delano and Whitin Avenues in an effort to reduce speeding.
  - 4. That the Mayor request the Traffic Commission to install a Stop Sign on Prospect Avenue going West, at the intersection of Homer Street.
  - 5. That the Mayor request the Traffic Commission to establish "No Parking" regulations on the south side of Revere Street from Sagamore Street to North Shore Road.
  - 6. Julie DeMauro request that the Traffic Commission amend Schedule VIII Parking Restrictions Generally by adding:

843 Broadway one-hour parking

- 7. The MBTA requests through Julie DeMauro that the Traffic Commission Amend Schedule XIV of Title 10 Bus Stops by:
- a. Removing the following:

This location would allow the 411 to serve Revere St before getting in the left-turn lane for N Shore Rd.
