Please request that the School Committee vote in approval of the following budget amendment at their November 19, 2024 meeting per our conversations regarding the School Department's contribution to the City of Revere's McKinley Mixed Use Renovation Project.

The School Department's contribution to the McKinley Mixed Use Project is \$6,900,000. \$2,446,371 of this was encumbered directly in ESSER III grants funds and has been obligated for 53% of the Project Management and Design Services costs. ESSER III is also funding \$4,453,629 for Transportation Services in FY25. With this BUA we are now making those funds (which the City would otherwise have obligated and spent in its transportation costs) available in an account where the funds can be used for the Mixed Use project.

Please note that this BUA does not affect any Net School Spending-eligible accounts. It only affects accounts that are funded through Schedule 19 on behalf of the City.
