**RE: Communication from the Election Commissioner requesting that the
City Council opt-in to in person early voting for 2025 municipal elections**

Dear President Silvestri:

The Board of Election Commissioners has voted to “opt-in” to the early voting provisions of the VOTES Act. The decision to “opt-in” to the early voting provisions requires the City Council to authorize this action, per M.G.L. c. 54 s. 25B(8)(c)(1).

I am asking the City Council to approve the following schedule for early voting:

Sunday, October 26, 2025	10:00 am – 2:00 pm
Monday, October 27, 2025	8:15 am – 5:00 pm
Tuesday, October 28, 2025	8:15 am – 5:00 pm
Wednesday, October 29, 2025	8:15 am – 5:00 pm
Thursday, October 30, 2025	8:15 am – 5:00 pm
Friday, October 31, 2025	8:15 am – 12:15 pm
