Zoning Sub-Committee Report

The Zoning Sub-Committee met on Monday, September 12, 2022 at 5:00PM in the City Councillor Joseph A. DelGrosso City Council Chamber, Revere City Hall, 281 Broadway, Revere, MA 02151. Committee members present were Councillors McKenna, Novoselsky, Powers, Serino, Visconti (ex-officio), and Chairman Keefe.

The following special permits were before the committee for discussion:

Enterprise Rent-A-Car Company of Boston, LLC, 50 Tomahawk Drive, Bldg. 49, East Boston, MA 02128 requesting a special permit from the Revere City Council to enable the appellant to operate an automotive/truck rental office and storage use at 85 Squire Road, Revere, MA 02151.

Council President Visconti offered the following conditions for the special permit:

- 1. Enterprise Rent-A-Car Company of Boston, LLC shall register a certain number of vehicles in the City of Revere to generate, at minimum, \$200,000 in annual excise tax payments to the City of Revere. Enterprise Rent-A-Car Company of Boston, LLC shall file with the City Council documentation of its compliance with this condition on an annual basis beginning July 1, 2023 and every year thereafter by July 1st. Enterprise Rent-A-Car Company of Boston, LLC shall hold in an escrow account an amount not less than \$200,000. Should Enterprise Rent-A-Car Company of Boston, LLC fail to register enough vehicles in the City of Revere to generate \$200,000 in excise tax payments in any given fiscal year, the difference shall be paid to the City of Revere from the escrow funds by July 15th.
- This special permit is only awarded to Enterprise Rent-A-Car Company of Boston, LLC and shall expire upon Enterprise Rent-a-Car Company of Boston, LLC no longer operating at 85 Squire Road, Revere, MA 02151.

Frank Stringi, City Planner recommend adoption of the following conditions for the for special permit:

- 1. A final landscaping plan shall be approved by the Site Plan Review Committee for streetscape and landscaped areas within the site,
- 2. A final Site Plan Review report shall be issued by the Site Plan Review Committee prior to the issuance of any building permit.
- 3. A MassDOT curb opening permit for a new use must be obtained prior to issuance of any building permit.
- 4. The City Engineer and Chief of Infrastructure shall review and approve utility plans for the sewer service, water service and stormwater management plan.
- 5. The plans shall be reviewed and approved by the Fire Department.
- 6. The vehicle storage capacity shall be limited to the 33 on site parking spaces provided on the site plan.
- 7. There shall be no stacking of vehicles allowed on the site.
- 8. Vehicles stored on the site shall not exceed the GVW 8,000 lb limit.
- 9. No repair, maintenance or body work shall be performed on the site.
- 10. All rental vehicles stored on site shall be registered in the City of Revere.

Enterprise was amenable to all conditions presented except for 10. All rental vehicles stored on site shall be registered in the City of Revere. Enterprise indicated that it would be difficult if not impossible to comply with this condition as vehicles from other cities or states may be dropped off at the proposed Squire Road location.

Chairman Keefe agreed and condition #10 was eliminated from consideration.

The Zoning Sub-Committee offered a unanimous favorable recommendation for the City Council to grant the relief requested subject to the conditions as discussed by the committee. Committee members McKenna, Novoselsky, Powers, Serino, Visconti (ex-officio), and Chairman Keefe voting in the affirmative.

596 Brothers, LLC and Beachmont Investments, LLC, 596 Revere Beach Boulevard, Revere, MA 02151 requesting a special permit from the Revere City Council to alter the preexisting nonconforming eight (8) unit structure by constructing eight (8) additional units over two (2) new floors at 451 Revere Beach Boulevard, Revere, MA 02151.

Frank Stringi, City Planner recommend adoption of the following conditions for the for special permit:

- 1. The final building design and exterior materials shall be approved by the Site Plan Review Committee.
- 2. Screening measures shall be incorporated along all sides of the parking lot area which borders adjacent residential uses.
- 3. The plans shall be reviewed and approved by the Conservation Commission.
- 4. A final Site Plan Review report shall be issued by the Site Plan Review Committee prior to the issuance of any building permit.
- 5. A landscaping plan shall be approved by the Site Plan Review Committee for streetscape improvements and landscaped areas within the site.
- 6. The City Engineer and DPW Chief of Infrastructure shall review and approve utility plans for the proposed sewer service, water service and stormwater management plan.
- 7. Hydrant flow tests shall be conducted on Revere Beach Boulevard to determine the adequacy of both domestic and fire flow and for the proper sizing of domestic and fire flow service to the building.
- 8. A sewer and water connection permit must be obtained from the DPW. In accordance with the current DEP Administrative Order and EPA Consent Decree, a sewer connection fee shall be paid to the City of Revere for 10/1removal of inflow and infiltration (1/1) from the sanitary sewer system. The formula for the sewer connection fee is based on 110 gallons/bedroom x 10 x \$1.30/gallon. Since the proposed development shall provide for 8 additional bedrooms, the 1/1 fee shall be \$11,440.
- 9. In accordance with Chapter 17.47, the Community Improvement Trust Fund is applicable to this development project. Under the Community Improvement Trust Fund, the developer is required to contribute 3% of the construction cost of construction above and beyond what is allowed as of right towards the fund, which must be used exclusively towards capital improvement projects within the impacted area. For the purpose of this special permit, 3% of the construction cost shall be based on the increased density of 8 additional units to a nonconforming structure.

The Zoning Sub-Committee offered a unanimous favorable recommendation for the City Council to grant the relief requested subject to the conditions as discussed by the committee. Committee members McKenna, Novoselsky, Powers, Serino, Visconti (ex-officio), and Chairman Keefe voting in the affirmative.

529 Broadway, LLC, 52 Fairview Street, Winthrop, MA 02152 to alter and extend a nonconforming use (nonconforming commercial building, acting as a private garage) for the purpose of operating a commercial garage at 535 Broadway, Revere, MA 02151.

Paul Tellier, Attorney for the applicant addressed the Zoning Sub-Committee. Attorney Tellier

worked with the neighboring abutter, Marie Shand, 130 School Street, to reach an agreement for various conditions for the special permit. One of the conditions presented was to not use the garage for repair purposes, but for autobody purposes only. The City Clerk notified the Zoning Sub-Committee that the applicant applied for a commercial garage use (repair) not a special garage use (autobody). The attorney requested that the special permit remain in committee for further clarification.

Attached please find amendments to the Zoning Map creating a Conservation District (CD) for conservation, open space and recreation uses only. This new zoning district will cover parcels within the TED, IP, HB, GB, RC1, RC2, RB, and RA1 districts that are currently protected marsh, wetland and open space areas within the city. These map amendments will further distinguish parcels that are environmentally significant and protected from future development and further support Revere's efforts towards flood resiliency.

Also attached is a Zoning Map amendment to rezone a sensitive floodplain area in Roughans Point within the block bounded by Broadsound Avenue, Roughans Street, and Winthrop Parkway from General Business (GB) to General Residence (RB). This area is predominantly comprised of single- and two-family homes and will be rezoned to reflect the current land use of this single- and two-family neighborhood.

An Act Relative to Voting Precincts in the City of Revere

SECTION 1. Chapter 22 of the Acts of 2012 is hereby repealed.

SECTION 2. Notwithstanding any general or special law to the contrary, ward 2, precinct 3 of the city of Revere shall be one precinct for the purpose of forming congressional, representative, senatorial, or councilor districts, but shall be two precincts for the purpose of forming representative districts.

One of these polling places shall be located at or near the Carl Hyman Towers located at 50 Walnut avenue to serve the voters residing in the area bound by Kimball avenue to the north, by Walnut avenue to the east, stretching from Kimball avenue to Shirley avenue, then by Sumner street to the east, stretching from Shirley avenue to Franklin avenue, then by Franklin avenue and Hichborn street to the southwest, and VFW parkway to the west, stretching from Franklin avenue and Hichborn street northeast of VFW parkway to Kimball avenue. This polling place shall be known as ward 2, precinct 3.

The other polling place shall be located at or near the Carl Hyman Towers located at 50 Walnut avenue to serve the voters residing in the area bound by Sumner street to the west, stretching from Shirley avenue to Franklin avenue, then by Shirley avenue to the north, stretching from Sumner street to Walnut avenue, then by Walnut avenue to the east, by Campbell avenue and Fitzhenry square to the southeast, by Centennial avenue to the southeast, and by Franklin avenue to the southwest. This polling location shall be known as ward 2, precinct 3A.

SECTION 3. Notwithstanding any general or special law to the contrary, ward 5, precinct 1 of the city of Revere shall be one precinct for the purpose of forming congressional, representative, senatorial or councilor districts, but shall have two polling places for the purpose of voting at any federal, state, or municipal elections.

One of these polling places shall be located in the Point of Pines neighborhood in the city of Revere to serve the voters residing north of Mills avenue at the point of intersection of Mills avenue and North Shore road. This includes all of the Point of Pines neighborhood, 182-371 North Shore road and 628 to the end of Revere Beach boulevard. This polling location shall be known as ward 5, precinct 1.

The other polling place shall be located at or near the Jack Satter House located at 420 Revere Beach boulevard to serve the voters residing south of Mills avenue at the point of intersection of Mills avenue and North Shore road. This includes people residing at the following addresses: 420-624 Revere Beach boulevard, 780-808 North Shore road, the even number addresses at 810-824 North Shore road, the odd number addresses at 35-81 Oak Island street, the odd number addresses on Alice street, 32-65 Glenwood street, the odd number address at 69-89 Glendale street, and all voters residing on Dashwood street and Vera street. This polling location shall be known as ward 5, precinct 1A.

SECTION 4. The election commission of the city of Revere may take all necessary actions to assure compliance with this act including, but not limited to, such actions as assuring the accuracy of the voting lists located at the polling place as set forth in this act. The election commission shall divide the precincts set forth in sections 2 and 3 into two subprecincts, and only the names of voters who reside in each such subprecinct shall appear on the voting list for said subprecinct.

Due to the passing of Councillor-at-Large George J. Rotondo, Jr. on September 11, 2022, there remains a vacancy in the office of councillor-at-large. The defeated runner-up for the office of councillor-at-large is Mr. Anthony T. Zambuto, 87 High St., Revere, MA 02151.

Therefore, pursuant to the above referenced statute, the City Council shall fill vacancy by selecting Mr. Anthony T. Zambuto to serve for the remainder of the unexpired term. I recommend the following form for the motion:

"Pursuant to Chapter 147 of the Acts of 2004, shall the City Council fill the vacancy in the office of councillor-at-large by selecting Mr. Anthony T. Zambuto?"
