Motions

13-282 Motion presented by Councillors Patch and Powers: That the Mayor request the Director of Veterans' Affairs to install a memorial sign for William C. Flynn, former City Councillor and U.S. Navy Veteran at the corner of Park and Washington Avenues.

13-283 Motion presented by Councillors Arrigo and Reardon: That the Mayor periodically, during the course of the negotiations with Mohegan Sun regarding a new host community agreement, address the City Council in Executive Session on the progress of the negotiation. The purpose of this motion, with the understanding that the Council may only advise and has no authority to execute an agreement, is to give the Mayor and his negotiating team the benefit of the thoughts, ideas and experience of the Council and to enhance the transparency of the negotiations. This motion also requests that prior to executing a host community agreement, the Mayor meet with the Council in Executive Session to provide the details of any such final agreement.

13-284 Motion presented by Councillor Guinasso: That the Mayor request the Traffic Commission and the School Department to look into the feasibility of placing a crossing guard at Mountain Avenue and Broadway at the request of area residents.

Legislative Bench

In keeping with the custom and tradition of the Revere City Council, the City Council honored six of its members by placing their names and years of service as members of the City Council on name plates on the City Council's legislative bench, which sits in the City Council Chamber, behind the members of the Council.

To receive the special recognition, City Councillors must have served for a decade or more on the City Council. Currently, the names of nineteen past and present members of the City Council are on the legislative bench.

Six City Councillors will be honored this evening by having their names and years of service placed on the Legislative Bench.

They are as follows:

- 1. Ward Three City Councillor, Arthur F. Guinasso's name is placed on the legislative bench with twenty-six (26) years of service as a member of the City Council.**
- 2. Councillor-at-Large, Robert J. Haas, Jr.'s name is placed on the legislative bench with twenty-two (22) years of service as a member of the City Council.**
- 3. Councillor-at-Large, Anthony T. Zambuto's name is placed on the legislative bench with fourteen (14) years of service as a member of the City Council.**
- 4. Ward Two City Councillor and 2013 Council President, Ira Novoselsky's name is placed on the legislative bench with fourteen (14) years of service as a member of the City Council.**
- 5. Ward Five City Councillor, John F. Powers' name will be placed on the legislative bench with thirteen (13) years and seven (7) months of service as a member of the City Council.**
- 6. Ward One City Councillor Richard A. Penta's name will be placed on the legislative bench with thirteen (13) years and three (3) months of service as a member of the City Council.**

Family Members Who Have Served on the Revere City Council

Former Councillor John R. Arrigo served on the Revere City Council from 1988 to 1993. His son, Brian M. Arrigo was first elected to the position of Councillor-at-Large in November of 2011 and has just completed his first term. Councillor Arrigo will begin his second term representing the citizens of Revere in 2014. As father and son, their names will be permanently affixed to the desk of the City Council President in the City Council Chamber.
