 - a. For each charge related to machines used for gambling, the Commission suspended the license for five days, of which five were held in abeyance for two years pending further violations; penalties were served concurrently.
 - b. The licensee must not possess in or on the licensed premises any automatic amusement device or video poker machine.
 - c. For changing officers and directors without authorization, and failure to file annual reports with Commission, license was suspended indefinitely – this suspension was reconsidered and reversed to a suspension of time served from January 21, 2014 to February 19, 2014.
