## ATTACHMENT

**Section 1.** Chapter 10.32 – Stopping, Standing, and Parking Generally is hereby amended by inserting the following new section:

### 10.32.074 Parking— Business Permit

A. Business parking zones are established between the hours of 8:00 A.M. to 8:00 P.M. except on Sundays or legal holidays in which business establishments are required by law to remain closed in designated municipal parking lots listed in Schedule IX(B) of Title 10 – Parking by Business Parking Permit Only of the Revised Ordinances of the City of Revere.

B. Businesses located within the city shall be eligible for the issuance of one (1) business parking permit for municipal parking lots listed in Schedule IX(B) of Title 10 – Parking by Business Parking Permit Only of the Revised Ordinances of the City of Revere upon presentation of the following information and documents:

1. A valid business certificate issued by the City of Revere – Office of the City Clerk;
2. A copy of a valid driver's license issued by commonwealth of Massachusetts Registry of Motor Vehicles; and
3. Vehicle registration issued by the commonwealth of Massachusetts Registry of Motor Vehicles.

C. The business parking permit shall be issued by the parking clerk upon payment of an annual fee of three-hundred and sixty dollars (\$360.00). The permit shall be valid for one year and shall expire on December thirty-first of each year. The permit shall state "Business Parking Permit" and the designated municipal parking lot for which the permit shall be valid. Business parking permits issued by the parking clerk pursuant to the statutes and regulations set out in this section are intended only for the use of businesses only.

D. The permit shall be displayed on the lower left corner of the front dashboard and must be readable from the exterior of the vehicle. Permits will not be replaced if lost. No person shall sell or offer for sale a business permit to anyone, or alter such permit. Any person who violates this section of this chapter shall have the permit revoked any may be subject to a fine of not more than three hundred dollars (\$300.00) for each offense.

**Section 2.** Title 10 is hereby amended by inserting a new schedule as follows:

### Schedule IX(B) of Title 10 - Parking by Business Parking Permit Only
