

PUBLIC NOTICE

Notice is hereby given in accordance with the provisions of Section 9 of Chapter 89 of the Massachusetts General laws and Chapter 185 of the Acts of 1983, as amended, that the Traffic Commission of the City of Revere will conduct a public hearing on June 27, 2013 at 4:00 pm in the City Councillor Joseph A. DelGrosso City Council Chamber of Revere City Hall relative to the following proposed amendments to the Traffic and Parking Regulations of the City of Revere:

Section 1. In accordance with the provisions of Section 3 (a) of Chapter 185 of the Acts of 1983, the Traffic and Parking Rules and Regulations of the City of Revere are hereby amended as follows:

Section 2. To amend Schedule V of Title 10, One Way Streets is by inserting the following:

McKinley St	northerly	Washington St	Revere St

Washington St	easterly	Cleveland St	McKinley St

Section 3. to address the intersection of Webster and Crescent Ave.

Section 4. Schedule XIX of Title 10, ON-STREET PARKING METER ZONES by removing the following:

And by replacing it with two hour parking 9AM to 5PM Monday through Friday

Section 5. Schedule VI of Title 10, Heavy Commercial Vehicles-Restricted Streets by adding Central Ave from Broadway to Beach St. both directions.

Section 6. Schedule XI of Title 10, Handicapped Persons Parking Areas by adding 19 Essex St.

Section 7. Schedule I of Title 10, Parking Penalties by adding: Group D Fine \$50.00 – Parking of any bus, taxicab, hackney, pupil or livery vehicle upon any street other than at a taxi stand.

Section 8. Schedule V of Title 10 One Way Streets by deleting:
