Section 4. Schedule XIX of Title 10 of the ON-STREET PARKING METER ZONES of the City of Revere is hereby amended by removing the parking meter in front of 208 Broadway and replace it with 15 minute parking.

Section 5. Schedule VIII of Title 10 of the Parking Regulations of the City of Revere is hereby amended by adding the following: Rose St. even side from Broadway to Pamona St. No Parking Anytime

Section 6. Schedule XI of Title 10, Handicapped Persons Parking Areas by adding 79 Shirley Ave.

Section 7. Title 10, Chapter 10.32, Section 10.32.160 of the Revised Ordinances of the City of Revere, Buses and Taxis Away from Stops or Stands, is hereby amended by ending the first sentence with a period after the words "at any time" and deleting the words, "between the hours of six p.m. and six a.m. The owner or lessee of any bus, taxicab, hackney, pupil or livery shall be allowed to park overnight between the hours of six p.m. and six a.m. within the municipal parking lot, the north lot or any other parking lot allowed by the parking clerk, provided such owner or lessee secures a parking sticker for such overnight parking. The fee and conditions for such parking sticker shall be determined by the parking clerk."

Section 8. Title 10, Chapter 10.32, Section 10.32.160 of the Revised Ordinances of the City of Revere, Buses and Taxis Away from Stops or Stands, is hereby amended by deleting the words "within a posted area" and inserting in place thereof, "a bus, taxicab, hackney, pupil or livery vehicle away from a taxi stand".

Section 9. Title 10, Chapter 10.44, Section 10.44.030 of the Revised Ordinances of the City of Revere, Tow-away zones—Removal of vehicles, is hereby amended by adding a new sub-section A.13. as follows:

"13. Buses, taxicabs, hackney, pupil or livery vehicles parked upon any way in accordance with Section 10.32.160 of the Revised Ordinances of the City of Revere."
