LICENSE COMMISSION MEETING

A SPECIAL MEETING OF THE Revere License Commission was called to order by Chairman Quarantello at 9:00 a.m. on April 25, 2014. Commissioner John M. LaCroix, and Maggie Haney, Recording Secretary, present.

Application for Special 1-day Entertainment License: Application of Wonderland Entertainment, LLC d/b/a **Wonderland**, Charles Delpidio, Manager, for special 1-day entertainment license, with closing time at 2:00 a.m., said license to be exercised on Sunday, April 27, 2014.

Mr. Taras Hrabec appeared for the application. In view of the upcoming reinstatement of closing hour of 2:00 a.m. for this establishment, the Commission elected to consider making the reinstatement effective on the date of the proposed 1-day license. The Commission asked Mr. Hrabec to describe the upcoming event on Sunday, and what their plan was to manage the event. The band plays Brazilian country music, with a fan base in the mid-twenties, and they expect a crowd of approximately 600-700.

Commissioner LaCroix asked about ticket prices for events. Depending upon the event, the price varies from \$30-\$75. When asked about security for this event, Mr. Hrabec said that he would have between 22 and 25 of his own security people, 3 detail police officers, and 1 detail fire officer.

Upon a motion duly made by Chairman Quarantello, and seconded by Commissioner LaCroix, it was VOTED to reinstate the 2:00 a.m. closing hour, effective Sunday, 4/27/2014.
