Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the minutes.

Expected attendance is 85 – 95.

Application for a 1-day Malt/Wine, Common Victualler, & Entertainment License: Application of City of Revere for a 1-day license for Malt/Wine, Common Victualler, and Entertainment, said license to be exercised at the Haas Wellness Center at 321 Charger Street on Friday, October 25, 2024 from 9 p.m. – 11 p.m. Event is a Haunt Fest Halloween party. Expected attendance is 100.

Haley Hanton appeared for the application. This will be a member appreciation party with a Halloween theme. It is open only to those aged 21 and over.

There were neither proponents nor opponents when called. Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the application.

There were neither proponents nor opponents when called. Upon a motion duly made by Commissioner Monroy, and seconded by Commissioner Occena, it was VOTED to approve the application.

388 Broadway, LLC d/b/a **Volare** 388 Broadway Cecilia Maya, Manager

Application for a Change of Hours and to Amend Entertainment License: Application of 388 Broadway, LLC d/b/a Volare, Cecilia Maya, manager, to change operating hours to Sunday – Saturday 10 a.m. – 2 a.m., and to amend entertainment to allow DJ on Sunday – Saturday 10 p.m. – 1 a.m. Current operating hours are Sunday – Saturday 11:30 a.m. – 1 a.m. Current entertainment allows DJ Sunday – Saturday 11 p.m. – 1 a.m.

Cecilia Maya appeared for the application. They wish to open a bit earlier for brunch and stay open later. Commissioner Selevitch alluded to earlier issues with security and the Commission asked for their plans to prevent issues with the later hour of closing. Ms. Maya stated they have plans to reduce the volume of the DJ and have engaged a security company to provide security from 10 p.m. - 2:30 a.m.

City Councillor Paul Argenzio and City Councillor Angela Guarino-Sawaya spoke in favor of the application. There were no opponents when called.

Upon a motion duly made by Commissioner Monroy, and seconded by Commissioner Occena, it was VOTED to approve the application.

Lupita Revere, LLC d/b/a **Lupita Restaurant** 111 Shirley Avenue Erasmo Guevara, Manager

<u>Application for a Change of Hours:</u> Application of Lupita Revere, LLC d/b/a Lupita Restaurant, Erasmo Guevara, manager, for a change of operating hours to Sunday – Saturday 11 a.m. – 2 a.m. Current operating hours are Sunday – Saturday 11 a.m. – 12 a.m., with entertainment closing at 11:30 p.m.

Erasmo Guevara appeared for the application, represented by his attorney, Joe Franzese. In July, the Commission had rolled the closing hour back to 12 a.m., due to excessive disruptions to the neighboring residents. Since that time, the business has installed double-paneled windows and a vestibule to reduce noise in the neighborhood, has instructed their staff to be more responsive to police direction to lower music or otherwise take actions to reduce area disruptions, and have arranged to hire police detail officers and extra time for their own security to help prevent patrons exiting the business from disturbing residents.

Commissioner Selevitch noted that the business had not obtained a building permit for their renovations, and directed the applicant to do so as soon as feasible. He acknowledged the steps taken to improve the business's operations, then reminded the applicant of the need to be mindful of the needs of neighboring residents. Commissioner Occena and Commissioner Monroy expressed concern for the neighbors, and emphasized that allowing this expansion of hours would be with the understanding that any future disruptions could result in another rollback of hours. However, the Commission agreed that the business deserved the opportunity to amend its operations.

There were neither proponents nor opponents when called. Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the application, and to allow entertainment to operate until 1 a.m.

Bob Kelley appeared for the hearing, represented by his attorney, James Cipoletta. Mr. Cipoletta detailed the steps taken by the licensee to complete his application to properly transfer ownership of the license and appoint a license manager. They have updated its records with the Secretary of the Commonwealth's Corporations Division, and have begun the probate process in Florida and Massachusetts.

Commissioner Selevitch made a motion to continue the matter until the December meeting, in order to allow time for the probate process to complete. The motion was unanimously approved.
