A REGULAR MEETING OF THE Revere License Commission was called to order by Chairman Robert Selevitch at 3:00 p.m. on November 20, 2024. Commissioner Daniel Occena, Commissioner Liliana Monroy, Police Lt. Sean Randall, Liaison with the Revere License Commission, and Maggie Haney, Recording Secretary, present.

Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the minutes.

## **VOTED ON THE FOLLOWING APPLICATIONS SUBMITTED FOR CONSIDERATION**

### The McClellan Highway Development Corp.

10 Suffolk Downs Boulevard Rachel Ottley, Event Manager

Application for (2) 1-day Common Victualler & Entertainment Licenses: Application of The McClellan Highway Development Corp. for two 1-day licenses for Common Victualler and Entertainment, said licenses to be exercised outdoors at 10 Suffolk Downs Boulevard on Saturday, November 30, 2024, and Sunday, December 8, 2024, from 12 p.m. – 3 p.m. Events are holiday fairs with Christmas tree pop-up, live music, non-alcoholic beverages, kids' crafts and food trucks. Expected attendance is 500 - 1000.

Rachel Ottley appeared for the application. These two events are family friendly holiday events meant to activate the space outside the new residential building at the site.

There were neither proponents nor opponents when called. Upon a motion duly made by Commissioner Monroy, and seconded by Commissioner Occena, it was VOTED to approve the application.

# **Revere Public Library**

179 Beach Street Don Martelli, Event Manager

Application for a 1-day Malt/Wine License: Application of Revere Public Library, 179 Beach Street, Don Martelli, Event Manager, for a 1-day license to be exercised at said location on Thursday, November 21, 2024, from 6 p.m. – 8 p.m. Event is a Books & Brews networking event for small businesses. Expected attendance is 30 – 40.

Don Martelli appeared for the application. This is a joint event by the library and the Chamber of Commerce, meant to help small business owners learn about the resources available at the library to help businesses.

Councillor Ira Novoselsky spoke in favor of the application. There were no opponents when called. Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the application.

## **Rockwal Realty Trust**

1380 North Shore Road Walter Geary, Manager

Application for a Change of Number of Spaces for a Commercial Parking Lot License: Application of Rockwal Realty Trust, Walter Geary, Manager, to change the allowed number of parking spaces for a Commercial Parking Lot license. Current number of parking spaces is 45. Proposed number of parking spaces is 32.

Jean Geary appeared for the application. Part of her business property is leased from National Grid, and during recent lease renewal discussions, National Grid informed her that it was a violation of her lease terms to use their part of the property for commercial parking. As a result, she finds it necessary to reduce the number of commercial parking lots to those that are on the part of the property that she owns outright.

Councillor Ira Novoselsky spoke on behalf of the application, stating that he had called National Grid on Ms. Geary's behalf, but had no success. There were no opponents when called. Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the application.

### 21 Revere Beach Blvd, LLC

21 Revere Beach Boulevard Michael Aldi, Manager

<u>Application to add Bottle Service for an All Alcohol Restaurant License:</u> Application of 21 Revere Beach Blvd, LLC, Michael Aldi, Manager, to add Bottle Service for an All Alcohol Restaurant license exercised at 21 Revere Beach Boulevard.

Michael Aldi appeared for the application. He plans to allow tables of four or more patrons to order a bottle of alcohol for tableside service by a TIPS-certified server. Commissioner Occena asked questions about the restaurant becoming more of a nightclub/lounge business. Mr. Aldi stated that they operate as a restaurant until around 9:30, then move the chairs and operate as a lounge until later in the evening. He attributed the change in business model to a revenue-generating attempt. He stressed that he does not want his business to become a disruptive influence in the neighborhood. He considers it more of a lounge than a nightclub. Commissioner Monroy asked about happy hour regulations, and was informed that there will be no violation of happy hour regulations, and that no patron would be able to pour from the bottle themselves.

There were neither proponents nor opponents when called. Upon a motion duly made by Commissioner Occena, and seconded by Commissioner Monroy, it was VOTED to approve the application.

Que Arepa Corporation d/b/a **Que Arepa** 163 Squire Road Guillermo Rodriguez, Manager

<u>Application for a Malt/Wine Restaurant License:</u> Application of Que Arepa Corporation d/b/a Que Arepa, 163 Squire Road, Guillermo Rodriguez, Manager, for a Malt/Wine Restaurant license to be exercised at the same location for an existing restaurant. Seating is 24, hours are Monday – Thursday, 6 a.m. – 12 a.m., Friday –

Sunday, 6 a.m. - 1 a.m. Alcohol service would commence no earlier than 10 a.m. on Sundays and 8 a.m. on weekdays.

Alexander Idarraga appeared for the application, accompanied by Chris Surian, who translated for Mr. Idarraga. The business is an existing restaurant which would like to add beer and wine to its offerings for its patrons. The operators have experience in liquor service in restaurants, and all employees will be TIPS certified.

There were neither proponents nor opponents when called. Upon a motion duly made by Commissioner Monroy, and seconded by Commissioner Occena, it was VOTED to approve the application.

## **MISCELLANEOUS**

**<u>Board Discussion:</u>** Board discussion about extending opening hours to serve food and non-alcoholic refreshments on New Year's Eve.

Upon a motion duly made by Chairman Selevitch, and seconded by Commissioner Occena, it was VOTED to allow on-premises liquor licensed establishments to remain open on New Year's Eve until 3 a.m., with all alcohol service ended and alcoholic beverages discarded by 2 a.m., food service and entertainment continued until 3 a.m. with the caveat that all live music must end at 2:30 a.m. and all patrons off the premises by 3 a.m.

**Board Discussion:** The Commission discussed recent concerns with Wonderland Entertainment, LLC d/b/a **Oceanside Events Center**. The business had inquired as to reducing the use of police detail officers; however, there have been recent incidents that raised concerns about security during their events. Commissioner Occena proposed having the owners come before the Commission for a formal inquiry on the record. Commissioner Monroy agreed with this assessment. Chairman Selevitch moved to have the establishment appear before the Commission for the next meeting. The motion was seconded by Commissioner Occena, and was unanimously approved.
