At a meeting of the Revere Retirement System (RRS), held on Wednesday, August 25, 2021, at 9:00 a.m. at 14 Yeamans St., Suite C2, Revere, the following Revere Retirement Board (RRB), members participated: Mr. Viscay, Mr. Manion, Mr. Cullen and Mr. Cataldo. Mr. Cataldo moved to defer the decision on whether to request an opinion from the RRB's medical advisor UMass DES on Mr. Covino until the next meeting. After discussion, Mr. Cataldo withdrew his motion. On an affirmative vote, Mr. Viscay moving, the RRB voting 4-0 to request an opinion from the RRB's medical advisor UMass DES and to provide all the documents which were submitted to PERAC. Mr. Zapolin will notify the parties.

The RRB discussed the accidental death application filed by Maureen Capano, survivor of Frank Capano, Jr. On an affirmative vote, Mr. Viscay moved to request a medical review from PERAC. Mr. Cataldo amended the motion to also include a review by the RRB's medical advisor UMass DES. On an affirmative vote, Mr. Viscay moving, the RRB voting 4-0 to approve the amended motion.

Mr. Zaleznik reported that the matter is scheduled for September and he has been attempting to contact the ADA. On an affirmative vote, Mr. Viscay moving, the RRB voting 4-0 to table the matter.
