## **Meeting Minutes**

At a meeting of the Revere Retirement System (RRS), held on Wednesday, January 25, 2023, at 9:00 a.m. at 14 Yeamans St., Suite C2, Revere, the following Revere Retirement Board (RRB), members participated: Mr. Viscay, Ms. Cody, Mr. Manion, Mr. Cullen and Mr. Cataldo.
