Meeting Minutes

January 26, 2022 - 10:15 a.m.

At a meeting of the Revere Retirement System (RRS), held on Wednesday, January 26, 2022, at 10:29 a.m. at 14 Yeamans St., Suite C2, Revere, the following Revere Retirement Board (RRB), members participated: Mr. Viscay, Ms. Cody, Mr. Manion, Mr. Cullen and Mr. Cataldo. Also participating in the meeting: Mr. Zapolin, Retirement Administrator. Mr. Zaleznik, Board Counsel, participated remotely.

Agenda Item 1 – Call to Order

Agenda Item 2a - Approval of Board Minutes

On an affirmative vote, Mr. Viscay moving, the RRB voting 5-0 to approve the regular minutes of the December 15, 2021 meeting of the RRB.

On an affirmative vote, Mr. Manion moving, the RRB voting 5-0 to take matters out of order.

Agenda Item 12a – Executive Session – Disability Application

On an affirmative vote, Mr. Viscay moving, the RRB voting 5-0 (Mr. Viscay-yes, Ms. Cody-yes, Mr. Manion-yes, Mr. Cullen-yes, Mr. Cataldo-yes) to convene in executive session to "discuss the reputation, character, physical condition or mental health, rather than professional competence, of an individual;" MGL c. 30A, s. 21(a)(1); specifically, to discuss the physical condition and mental health of Joseph Covino. Mr. Covino, his counsel Daniel Fogarty and his counsellor Jeffrey Zeizel participated. Mr. Viscay noted the reasons for the executive session and noted that the RRB would convene in public session after the executive session. The RRB will maintain minutes of the executive session. The RRB again convened in public session.

On a negative vote, Mr. Cullen moving, the RRB voting 2-3 (Mr. Viscay-no, Ms. Cody-no, Mr. Manion-yes, Mr. Cullen-yes, Mr. Cataldo-no) to approve the accidental disability retirement application of Joseph Covino based on the PERAC medical panel and UMass Medical School DES opinion.

On an affirmative vote, Mr. Viscay moving, the RRB voting 5-0 to seek clarification from the medical panel and UMass Medical School DES on issues related to causation and medical records. Mr. Zaleznik will draft clarification questions.

On an affirmative vote, Mr. Cataldo moving, the RRB voting 5-0 to approve the ordinary disability application of Joseph Covino based on the PERAC medical panel and UMass Medical School DES opinion, without prejudice to further action. Mr. Zaleznik will draft findings of fact.

The Board returned to the regular order of business.

Agenda Item 3 - Legal Matters

The RRB discussed the option selection issue of the late Thomas Doherty. Mr. Zaleznik reviewed the issue and PERAC's opinion letter. On an affirmative vote, Mr. Cataldo moving, the RRB voting 5-0 to approve paying Option C benefits to Mr. Doherty's spouse, Marilyn Doherty. Mr. Zapolin discussed that the Retirement Analyst had gone through all retiree files and determined that only one other retiree did not properly select an Option C beneficiary and that beneficiary pre-deceased the retiree. Mr. Zaleznik also reviewed the *Bisignani v. Justices of the Lynn Division of the District Court et al.* decision concerning pension forfeiture.

Mr. Zaleznik left the meeting at 11:55 a.m.

Mr. Zapolin discussed that Robert Barry had submitted a completed Annual Affidavit to the Board after receiving service from the Sherriff. On an affirmative vote, Mr. Cataldo moving, the RRB voting 5-0 to place the matter on file.

Agenda Item 8 – Survivor Benefits

Mr. Zapolin discussed the application for benefits under MGL c. 32, s, 12(2)(d) of Raymond Nickerson, survivor of Priscilla Nickerson. Mr. Zapolin noted that Ms. Nickerson had not named an Option D beneficiary and lacked two years of creditable service, even after looking at the potential for Mr. Nickerson to purchase creditable service for Ms. Nickerson's non-membership employment. On an affirmative vote, Mr. Manion moving, the RRB voting 5-0 to deny Mr. Nickerson's application for benefit under MGL c. 32, s, 12(2)(d) and to pay the balance of Ms. Nickerson's annuity savings fund to Rose Lydon, Ms. Nickerson's beneficiary. Mr. Zapolin will notify Mr. Nickerson and Ms. Lydon.
