The City of Revere shall receive General Bids at the City of Revere Purchasing Department, 281 Broadway, Revere, Massachusetts for the Construction of the Intersection Improvements Location 12 – Bell Circle project, Contract No. MUN-2026-1011, prior to 11:00 A.M. prevailing time, June 11, 2026, at which time bids will be opened and publicly read aloud. Bids submitted after this time will not be accepted.

The project includes proposed improvements to improve traffic operations for vehicles entering the approach to Bell Circle from Beach Street. The early action improvements are consistent with the Massachusetts Department of Transportation (MassDOT) Section 61 findings and the anticipated scope of the final design concept for this area of Bell Circle. Specific design elements for the early action design include:

- Exclusive right turn lane from Beach Street to Route 1A eastbound
- Median and circle island modifications in the southwest quadrant
- Pavement markings and traffic signage in the southwest quadrant
- Sidewalk, driveway, and pedestrian ramp reconstruction in the southwest quadrant
- Pavement resurfacing in the southwest quadrant

Contract Documents shall be obtained electronically from the Office of the Purchasing Agent, City Hall, Revere, Massachusetts, beginning May 20, 2026, at [purchasing@revere.org](mailto:purchasing@revere.org). Hard copies of the Contract Documents will not be provided to plan holders. All requests must include a company name, address, contact name, contact phone number, email address, and request for access to the bid documents for the Intersection Improvements Location 12 – Bell Circle Project. Each Bid shall be submitted in accordance with the Instructions to Bidders and be accompanied by a Bid Security in the amount of five percent (5%) of the Total Bid Price.

The Successful Bidder must furnish a 100 percent Performance Bond and a 100 percent Payment Bond with a surety company acceptable to the Owner, the City of Revere.

Bidders may not withdraw their Bid for a period of thirty days, excluding Saturdays, Sundays, and legal holidays, after the actual date of the opening of the Bids.

The Contract to be awarded as the result of this Advertisement for Bids will be funded through the MassWorks Grant Program. The Commonwealth of Massachusetts is not a party to this Contract. All bidders shall be determined to be an eligible bidder for the category of work "Highway - Construction" for the project with an estimated value of \$345,086.00 by the Massachusetts Department of Transportation Highway Division Prequalification Office as required under the MassWorks Grant program.

Minority Business Enterprise (MBE) and Women's Business Enterprise (WBE) policies of the

Massachusetts Department of Transportation Highway Division are applicable to this Contract. The goals for this project are a minimum of: (1) a minority employee work force goal of 15.30 percent, (2) a women employee work force goal of 6.90 percent, (3) a goal of 7.24 percent participation of Minority-owned Business Enterprise(s), and (4) a goal of 3.60 percent participation of Woman-owned Business Enterprise(s) within the project Contract.

The Project requires compliance with the Massachusetts Diesel Retrofit Program (MDRP) by use of after- engine emission controls that are EPA certified, or their equivalent, on at least 50 percent of the off-road (non-registered) diesel vehicles/equipment used at the job site.

Failure to comply with these requirements may be deemed to render a proposal nonresponsive. No waiver of any provision of these requirements will be granted unless approved by the City of Revere or Massachusetts Department of Environmental Protection.

The City of Revere is an Equal Opportunity Employer. The City encourages MBE/WBE participation in response to the bid process.

Minimum Wage Rates as determined by the Deputy Director of the Department of Labor and Workforce Development under the provision of M.G.L., Chapter 149, Section 26 to 27H, as amended, apply to this Project. It is the responsibility of the Bidder, before the Bid opening, to request, if necessary, any additional information on Minimum Wage Rates for those trades people who may be employed for the proposed Work under this Contract.

This Contract contains price adjustments for hot mix asphalt, diesel fuel and gasoline. For this project the base prices are as follows: liquid asphalt \$670.00 per ton, diesel fuel \$4.568 per gallon and gasoline \$3.373 per gallon. The Owner reserves the right to reject any or all bids, to accept any bid, to waive any informality on bids received, to omit any item or items deemed advisable for the best interests of the Owner or to limit the extent of the Work to keep within the limits of available funds.

Complete instructions for filing Bids are included in the Instructions to Bidders.

The bidding and award of this Contract will be under the provisions of M.G.L. Chapter 30, Section 39M.

If the bidder views/obtains the plans and specifications from a source other than those noted in this Advertisement for Bids, the accuracy and/or completeness of the bid documents cannot be guaranteed and the bidder assumes the responsibility for obtaining any additional information regarding the project, including addenda that may be required for bidding. Failure to acknowledge addenda issued during bidding shall designate a bid as non-responsive.
