### **DESCRIPTION:**

Under the supervisions of the Aquatics managers, Lifeguards are responsible for monitoring and supervising aquatic activities. Their primary duties include overseeing swimmer safety, rescue operations and staying alert to changing conditions. Lifeguards are professional rescuers, trained to help prevent injuries and to respond in an emergency to help save a life. As part of a team, lifeguards must work together to calmly and efficiently manage crisis situations. Lifeguards must be 16 years or older and have a vailed lifeguard certification.

### **ESSENTIAL FUNCTIONS:**

The essential functions or duties listed below are intended as illustrations of the various types of work that may be performed. The omission of specific statements of duties does not exclude them from the position if the work is similar, related, or logically assigned to the position.

- Supervising swimming activities at the aquatic center and making sure that safety procedures, guidelines and policies are followed
- Explain and enforce safety regulations and rules
- Responds to emergency situations

- Administers and coordinates emergency first aid as necessary
- Remain rescue ready at all times
- Assess the swimming capabilities of everyone in the aquatics area and administers swim tests as needed
- Monitor for any safety hazards, and assist in activities and Advises aquatics management of unsafe and unsanitary conditions
- Provides superior customer service to all guests by assisting all in a polite and expedient manner
- Able to take attendance and assist aquatics managers at the front desk
- Maintains accurate daily pool records as well as sustain sanitary conditions in and around the pool, locker rooms, shower and toilet areas.
- Ability to work flexible hours.
- Performs related work as required.

## **QUALIFICATIONS:**

- 16 years of age or older.
- Qualified applicants must have current certification in ARC Lifeguard Training, certification in Standard First Aid, BLS-C.P.R. or comparable.
- Knowledge of pool health and safety standards preferred.
- Ability to work flexible hours.
- Proficient communication skills, both verbal and written.
- Proficient in interacting with people of various ages from diverse backgrounds.
- Available to work shifts.
- Physically fit, strong, agile, and dexterous.
- Ability to exercise good judgment and focus on detail as required by the position

# PHYSICAL ENVIRONMENT

Lifeguards will work on and around the pool deck and are expected to be comfortable in and around the water. Lifeguards are expected to be able to Sit or stand for extended periods of time and be capable of prolonged exposure to hot and humid environment. Lifeguards are expected to be able to swim a minimum of 100yds and retrieve and object from 12ft. All lifeguards will be held to the ARC standard.
