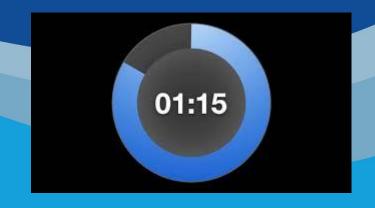

- The valve vault is expected to be placed in a couple weeks.



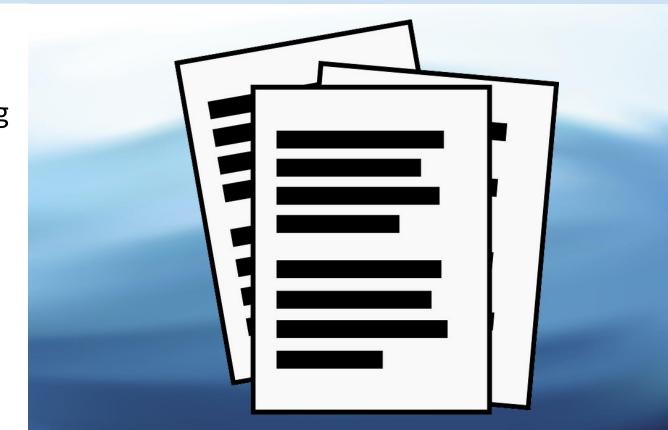
Turtle Run Water Main Replacement

- The remaining service work is expected to happen before the end of the month.



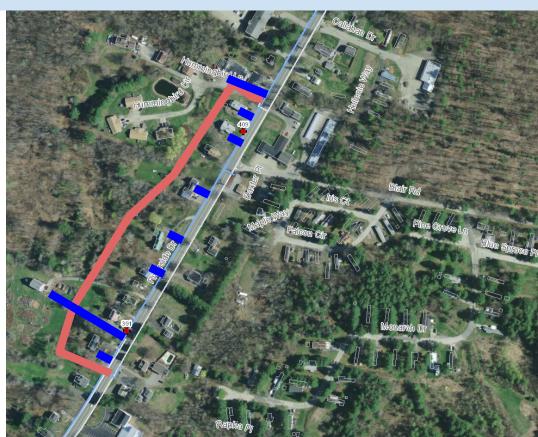

 This is due primarily to grant funds received for the River Crossing Project.
- Expenses were \$3.4M which is 5% under budget and approximately \$369K above the same period last year.

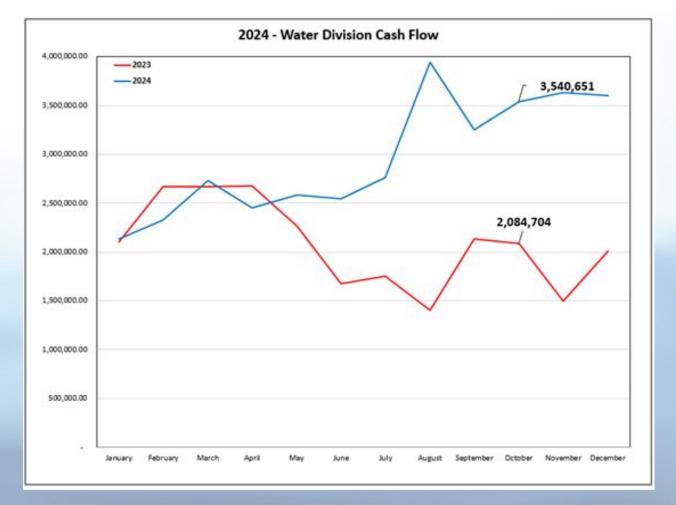

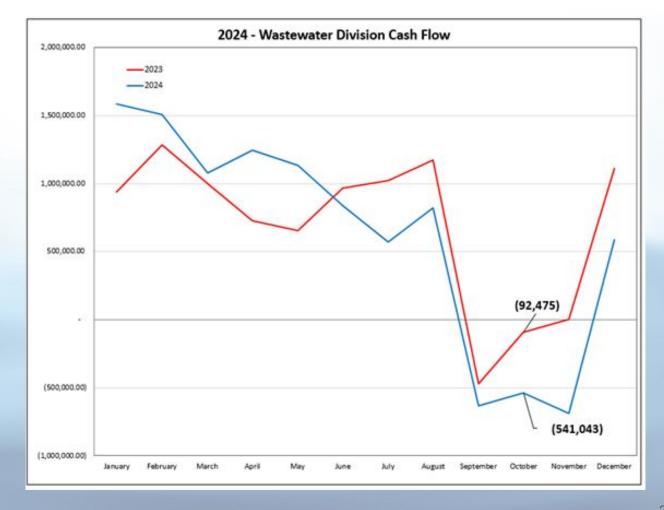

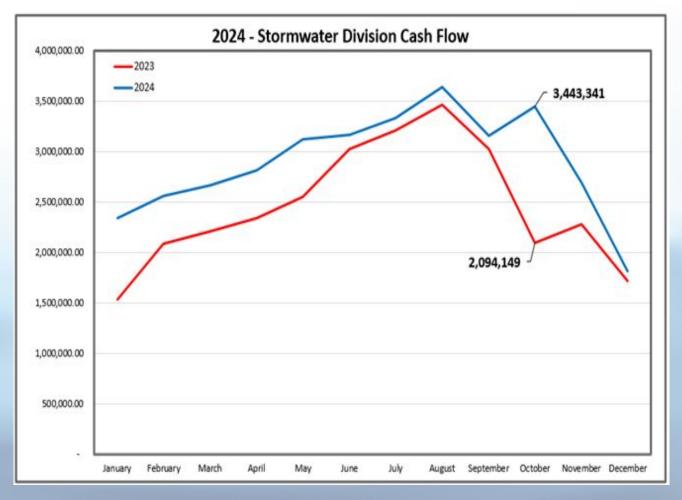
