TOWN OF WELD

PARADE ORDINANCE

ADOPTED June 17, 2025

SECTION 1. PURPOSE AND SCOPE

The purpose of this Parade Ordinance ("Ordinance") is to protect the safety of participants in a parade, road race, athletic event, walk, procession, or gathering held on the Town's public ways ("Event") and the citizens of the Town during such an Event.

This Ordinance shall not apply to (1) funeral processions; (2) Town or public school organized events, or (3) Events organized by the United States armed forces.

SECTION 2. PERMIT APPLICATION

Any person(s) or organization ("Applicant") may hold an Event by first obtaining written permission (a "Parade Permit") from the Town's Select Board by submitting the application form substantially attached hereto as <u>Form 1</u> ("Application") to the designated Select Board member ("SB Member").

Below are the requirements of the Application.

- 1. The application for a Parade Permit must be filed with the SB Member fourteen (14) days prior to the proposed date of the Event.
- 2. The application for the Parade Permit shall set forth the following information:
 - a) the name, address and telephone number of the Applicant including the person organizing the Event;
 - b) a brief description of the Event;
 - c) the proposed date and time period for the Event;
 - d) the route over the Town's public ways to be occupied by the Event;
 - e) the approximate number of anticipated participants (including any vehicles or animals) in the Event; and
 - f) confirmation that the Applicant has obtained the relevant insurance policy for such an Event and, if necessary, that the Town has been added as an additionally insured party to that policy. If applicable, the Applicant must attach a copy of such insurance certificate listing the Town as an additionally insured party to the Application.

SECTION 3. APPLICATION APPROVAL STANDARDS

Upon review of the Application, the SB Member shall issue a Parade Permit to the Applicant if he/she finds that:

- A. the Event will not substantially interfere with the safe and orderly movement of other traffic on the Town's public ways, and
- B. the Event will not hinder the citizens of the Town from receiving police and fire protection services.

SECTION 4. RIGHT OF APPEAL

The SB Member shall act upon the application for a Parade Permit within seven (7) days of receiving the Application. If the SB Member denies the Application ("Denial"), the Applicant may appeal the Denial to the Select Board in writing within three (3) days from the date of the Select Board member's decision ("Appeal"). The Select Board shall act upon the appeal within three (3) days of receipt of the Appeal.

This Ordinance is adopted by the Select Board of the Town of Weld at a properly noticed meeting on <u>Jone 17</u>, 2025.
