- One (1) Amkus ICT614 Midsize Combi Extrication tool with charger, and Batteries, Price: \$9,722.48
- One(1) Cascade Rescue Professional Series Stainless two piece Litter with Terra Tamer attachable wheel

Article 3: To see if the Town will accept and appropriate an **in-cash donation of \$587.78** from Brent Daughtery to the Town's Fire Department's Donation Revenue Account.

Article 4: To see if the town will vote to accept a \$566,891.34 grant from the Federal Emergency Management Agency (FEMA) of which **approximately \$370,000** will be Appropriated toward expenses necessary, including reimbursement of expenses previously incurred, for recovery from the natural disasters experienced bi May 2023 and December 2023, and of which **\$150,000** will be used to purchase gravel for the grading of Town roads.

Article 5: To see if the Town will appropriate \$3,202.51 from the General Fund LRAP Kennedy Bridge Repair Account to the LRAP Kenedy Bridge Repair Expense Account for a **repayment of \$3,202.51**.(interest only) of the Maine Municipal Bond Bank 2025 Series A (due November 1, 2025)
