## For 55 years of age and older

### **EDUCATION**

#### **University of Alaska Fairbanks**

Alaska residents who are 66 years or older and receiving full Social Security Benefits can attend any school in the University of Alaska system without paying tuition.

Seniors must meet other admission criteria and may have to pay other associated fees and enrollment expenses

### **GROCERY STORES**

#### **Fred Meyer**

First Tuesday of every month offers 10% off to *55+* and an additional 10% off select items

#### **Sunshine Health Foods**

First Tuesday of every month offers 10% off to *55+*

#### **The Roaming Root Cellar**

First Monday of every month offers 10% off all food items and select soap, shampoo, conditioner, and deodorant

No age restrictions

### **OTHER SERVICES**

#### **FNSB MACS Transit Bus Fares**

Free fare to ages *60+*

Required to show government-issued photo identification

#### **Senior Property Tax Exemption**

Alaska Statute 29.45.030(e) exempts real property owned and occupied as a primary, permanent place of abode by a resident age 65 and older (or by a disabled veteran) from a portion of local property tax.

Currently, this exemption applies to the first \$150,000 of assessed value of the property of a senior citizen, age 65 years and older, a disabled veteran, or widow/widower (at least 60 years of age of a person who qualified for the senior citizen or disabled veteran exemption).

This exemption must be applied for by a deadline enacted at the local level. (A municipality may waive timely filing for good cause.) All municipalities are required to grant this exemption

#### **State Of Alaska Division Of Motor Vehicles**

Alaska residents who are 65 years of age or older may be exempt from paying fees and taxes when registering a vehicle.

#### **State Of Alaska Fish & Game License**

907-465-6085

Alaska residents who are 60 years of age or older and meet the Department of Fish and Game's residency definition are eligible for a senior identification card in order to hunt, sport fish, or trap at no charge.

Persons aged 60 years or older are not required to purchase a king salmon stamp to fish for king salmon or an Alaska state conservation stamp to hunt waterfowl
