I understand that any materially false statement on this application may be subject to revocation or denial of a license.

I **certify** that I am a natural born or a fully-naturalized citizen of the United States., that I am at least 18 years of age or older, that I am not addicted to the use of intoxicants or narcotics, that I am of good moral character and repute, that I am not a sex offender or kidnapper subject to the registration requirements of AS Title 12, Chapter 63, that I have read and understand FGC 14.121-133, and that I understand the requirements for licensure.

Further, I hereby authorize the City of Fairbanks to obtain information pertaining to any charges and/or convictions I may have had for violation of municipal, county, state or federal laws. This information will include, but not be limited to, allegations regarding, and convictions for, crimes committed upon minors. I understand that this information will be gathered from any law enforcement agency of this state or any state or federal government, or from third-party providers of information originally obtained from law enforcement or court records.

As an applicant for a private detective license, I hereby attest to the truthfulness of the representations I have made. Except as I have disclosed, I have not been found guilty of, or entered a plea of nolo contendere or guilty to any offense.

I understand that I must be truthful and, if any statement I have made is found to be false, I will be denied the license for which I am making application.
