**Proposed Amendment to the City Charter Tax Cap Providing that any new or additional sales tax proceeds must be used to reduce the City base 4.9 mill levy to 0 mills before any other use.**

Shall the City Charter be amended as follows? (new text **underlined and bold**)

#### **Sec. 6.5. Total amount of city tax that can be levied.**

A. Except as provided in this section, the total amount of municipal tax that can be levied during a fiscal year shall not exceed the total amount approved by the city council for the preceding year by more than a percentage determined by adding the percentage increase in the Federal Consumer Price Index for Anchorage from the preceding fiscal year. Of the total amount of taxes that can be collected, property taxes are limited by a maximum **base** mill levy of 4.9 mills subject to Charter Section 6.5(B). Any new or additional sales tax levied, other than hotel/motel, alcohol, and tobacco, must be approved by the voters in a general election, **and the proceeds of any new or additional sales tax must be applied in the following fiscal year to reduce the city 4.9 base mill levy to 0 mills before any other use of the proceeds is allowed.**

B. The limitations set forth above in subsection A of this section do not apply to the following:

1. Taxes on new construction or property improvements which occur during the current tax assessment year.
2. Any appropriation made to pay or secure payment of principal and/or interest on bonds.
3. Taxes required to fund additional services authorized by voter approved ballot issues.
4. Funding of new judgments entered against the City of Fairbanks.
5. Special appropriations necessary on an emergency basis to fund unavoidable expenses insuring the public peace, health or safety.
6. Any taxes approved by the voters.

C. Increases in the hotel/motel tax levied by the city above the 1999 level shall be exempt from the application of Section 6.5.

**PROPOSITION NO. 2 (Failed)**

**Enactment of a 3% General Sales Tax for Additional City Services.**

(a) Shall Article VII (Sections 74-300 through 74-323) of the Fairbanks General Code of Ordinances be enacted to authorize a general sales tax of 3%, effective May 1, 2010, to fund the following additional City services, as allowed by Section 6.5(B)(3) of the City Charter:

- (1) additional street maintenance and street reconstruction services above 2009 levels, not to exceed the sum of \$4 million dollars a year above the City 2009 Public Works budget, adjusted annually by the full year change in the Anchorage Consumer Price Index (CPI-U); and
- (2) additional Public Safety services above 2009 levels, not to exceed the sum of \$4 million dollars a year above the City 2009 Public Safety budget adjusted annually by the full year change in the Anchorage Consumer Price Index (CPI-U),

(b) The proceeds of the sales tax provided in section (a) shall be applied:

- (1) First, to reduce the City base mill levy from 4.9 mills to 0 mills in the following fiscal year,
- (2) Then, for additional City service as stated in subsections (a)(1) and (a)(2).

(c) The sales tax shall be suspended annually if sufficient funds are received to fully fund subparagraphs (b)(1) and then (b)(2) and any excess proceeds shall be carried forward to the next fiscal year subject to the same limits on use and appropriation.

(d) Approval of this Initiative shall have no effect on existing sales taxes on alcohol, tobacco or the Hotel/Motel tax, none of such taxable sales shall be subject to this general sales tax.

### PROPOSITION NO. 3 (Passed)

**Information:** Current changes to state law have had the unintended effect of limiting the number of individuals who will seek public office. Some of the information required actually conflicts with other laws that require confidentiality on the part of certain professions. Many Alaskan communities have exercised their right to “opt-out” of the new state financial disclosure requirements, and have adopted their own code of ethics and financial disclosure requirements similar to what the state required prior to the 2007 changes.

#### **THE CITY OF FAIRBANKS TO ADOPT A CODE OF ETHICS AND FINANCIAL DISCLOSURE LAW AND EXERCISE ITS RIGHT TO “OPT-OUT” OF CURRENT STATE DISCLOSURE LAWS**

Shall the City of Fairbanks exercise the option to withdraw municipal public officials from the State of Alaska Public Official Financial Disclosure Law (AS 39.50), and instead adopt local ordinances that were similar to the requirements prior to the 2007 amendments, starting January 1, 2010?

## Special Election – April 3, 2007

**Introduction:** Since 1987, the city has operated within a voter approved tax cap which is still in effect today. The passage of Proposition 3 in October 2006 reduced the tax mill rate for commercial and residential properties from 6.7 mills to 0.5 mills (effective rate approximately 1.5 mills when claims, judgments, and bond debt are added to this 0.5 base). This left the city with a \$10.3 million shortfall. The city's total budget is \$30 million including capital expenses of which property taxes would normally make up 44%, the balance coming from sales taxes, fees, and permanent fund earnings. The city council recently reduced the mayor's proposed 2007 budget and is establishing committees consisting of city residents and council members to look into each city department's budget for efficiencies and cost containment. Increased revenue sharing from the state will also be used to reduce taxes in years it is received. The proposed mill rate is significantly lower than the prior year and continues a downward trend for the last several years. Recent attempts to establish new taxes to reduce the deficit such as the employment tax, residential emergency service tax, and gross receipts tax on businesses have been halted by referendum or the need for further work. None of these will be implemented if the Proposition A is approved by the voters. The mayor and unanimous city council believe that unless the deficit is reduced significantly, some amount of essential police, fire, ambulance and public works services will have to be eliminated.
