Local Voting Method Information

Local elections are conducted using a majority voting method, which is to vote for one candidate per race. The only exception is the North Pole Council seats, which asks voters to select no more than four candidates to fill four offices. The candidates with the first and second most votes will be assigned three-year terms, the candidate with the third most votes will be assigned a two-year term, and the candidate in fourth place will be assigned a one-year term.

The State of Alaska General Election uses a Ranked Choice Voting method. However, **Ranked Choice Voting is NOT used in local municipal elections.**







Our \$250,000 investment has gotten a \$700,000 return for building upgrades downtown.

I was able to stop the outflow of Police Officers and start the growth with very aggressive financial packages that did not hurt the cities financial status. We grew the Fire Department by 25% so we could implement a 3rd ambulance, a Community Paramedic and stop the fiscal drain of overtime. The downtown Golden Heart Plaza, from April - October now has a police and security patrol presence. I implemented a snow plowing requirement of 4 days. Day 1 are the main traffic arterials, days 2-4 are subdivisions being plowed.


More importantly, I think our current council works well together and I look forward to working with them another 3 years.




