FAIRBANKS CITY COUNCIL REGULAR MEETING MINUTES, JANUARY 27, 2025 FAIRBANKS CITY COUNCIL CHAMBERS 800 CUSHMAN STREET, FAIRBANKS, ALASKA

The City Council convened at 6:30 p.m. on the above date, following a 5:30 p.m. Work Session for the Permanent Fund Review Board Annual Report, to conduct a Regular Meeting of the Fairbanks City Council via Zoom webinar and in the City Council Chambers located at 800 Cushman Street, Fairbanks, Alaska, with Mayor David Pruhs presiding and the following Councilmembers in attendance:

INVOCATION

The invocation was given by City Clerk Danyielle Snider.

FLAG SALUTATION

At the request of Mayor Pruhs, Ms. Sprinkle led the flag salutation.

CEREMONIAL MATTERS (Proclamations, Introductions, Recognitions, Awards)

Chief of Staff Michael Sanders introduced Skye Kaquatosh, a student from West Valley High School currently participating in an internship with the Mayor's Office.

CITIZENS' COMMENTS

[Clerk Note: Names of citizens who provide comments may not be spelled correctly if their name was illegible on the physical sign-up sheet.]

Bobby Nikolaides, Chef & Owner of Bobby's Downtown – B. Nikolaides addressed problems he has experienced with incidents at the downtown post office and admitted that he does not know how to approach the situation, nor does he have any answers. He shared details of the constant presence of intoxicated individuals who loiter at the location, which is across the street from his restaurant. He described how the individuals frequently enter his business and create scenes, including assaulting staff, some of which are minors. B. Nikolaides reported that he has witnessed individuals dropping their pants to relieve themselves out in the open, on the public street, in the presence of his employees and younger patrons. He stated that it has been going on for years and recounted the story of a man setting himself on fire inside the post office some years ago. He explained that he called emergency services and ran across the street with a fire extinguisher. He noted that the individual died from his injuries, yet he was never contacted by anyone to discuss the incident, nor was his staff. B. Nikolaides asserted that the problems persist, that the list of events is endless, and that something has to be done. **Mayor Pruhs** invited B. Nikolaides to stay for Mayor's Comments, as he planned to speak about the post office issue at that time.

Mr. Marney asked if the situation seemed to be getting better or worse. B. Nikolaides declared that it is only getting worse. He gave the example of people asking to use the restroom in his restaurant, which he recognizes as a basic human need and always wants to allow, but they often do not come out for over half an hour, which requires that he or another employee check on the situation. He shared that on more than one occasion they have found individuals passed out in the restroom, sometimes even naked, and that it continues to create a terrible environment for his business. Mr. Marney acknowledged that B. Nikolaides does a lot for the community, including providing meals for those in need. B. Nikolaides insisted that he believes restaurants have a special opportunity to help and that he intends to continue to do so. He clarified that it is the same group of offenders who are making it a terrible situation for everyone else. He reiterated that the problems only seem to get worse.

<u>Scott McCrea</u>, <u>President and CEO of Explore Fairbanks</u> – S. McCrea extended an invitation for the Mayor and Councilmembers to attend Explore Fairbanks' Interior Tourism Conference. He discussed the lineup of speakers, topics, and events as well as a planned reveal for their new mascot. He committed to sending a detailed invitation via email and added that they are welcome to attend anything from a single presentation up to the entire conference.

<u>Victor Buberge</u> – V. Buberge pointed out that it had been a while since anything had been shared about the Polaris Building and asked for an update on the City's plans for the property. He alleged that the crane involved with the demolition had not adhered to OSHA standards the previous summer, and he expressed concern over the potential for injuries. He asked that the public be kept informed about the project.

Brynn Butler, Housing and Homeless Coordinator for the City of Fairbanks – B. Butler shared details about the upcoming Project Homeless Connect event that serves as a one-stop-shop to help connect individuals with services available in the community. She addressed the problems at the post office and offered to share her business card with any interested parties. She stated that if there is ever a situation that feels beyond someone's capacity to handle, they are welcome to call her and she will try and help. She added a disclaimer that she is not a police officer nor does she have any enforcement authority. B. Butler indicated that she is aware of a group of about 10 to 12 individuals who have been creating disturbances and that she is known among the unhoused community as someone who means business.

Mr. Cleworth asked what the hours of operation are for the new warming shelter. B. Butler shared that the facility is open from 10:00 p.m. to 7:00 a.m. every day of the week.

Ms. Sprinkle asked if things had gone well since the shelter opened. B. Butler indicated that she is glad the facility is open and is well-attended by those who need it. She acknowledged that she had heard of a few difficult situations but that she is not privy to the details. She shared that she will be visiting the shelter in the near future and would report on what she learns.

Mr. Cleworth asked about the shelter's capacity. B. Butler replied that the capacity is 49 people.

Mayor Pruhs, hearing no requests for additional comments, declared Citizens' Comments closed.

Mr. Marney, seconded by Ms. Sprinkle, moved to WAIVE PROTEST on the alcohol license applications for renewal.

Mayor Pruhs called for testimony and hearing none, declared Public Testimony closed.

Ms. Sprinkle asked for clarification on a notation within the application packet. Clerk Snider explained that recent rewrites of regulations of alcohol licensing have updated classifications for certain situations and that one of the businesses has a split, fixed counter setup, which is categorized differently than it was in the past. Ms. Sprinkle thanked her for the clarification. She noted the recent tragedy where an individual was shot outside of the Midnite Mine, which had nothing to do with their alcohol service or other business activity. She expressed hope that the incident would not impact the Council's decision.

Ms. Therrien, seconded by **Ms. Sprinkle**, moved to WAIVE PROTEST on the marijuana license applications for renewal.

Mayor Pruhs called for testimony and hearing none, declared Public Testimony closed.

Mr. Cleworth stated that he was aware of some complaints regarding odor from the manufacturing and cultivation facilities in the Well Street area. He asked if the concerns had been addressed with the business owners. **Mayor Pruhs** shared that he receives odor-related complaints for that side

of town about once every four to five months and that the business owners are proactive about resolving the issues. He explained that when he receives complaints of this type, he reaches out to request that they check their exhaust systems. He stated the community should not have to live with the smell and that the responsive actions from owners have been appreciated.

Mayor Pruhs declared the MOTION CARRIED.

MAYOR'S COMMENTS AND REPORT

Mayor Pruhs invited Joe Dallaire, the District Attorney (DA) in Fairbanks, to provide a report.

J. Dallaire recounted having attended a City Council meeting a few months prior when he gave an impromptu report on his office, which resulted in a request that he return periodically to provide updates. He discussed the large jurisdictional area that the Fairbanks DA's office covers, the various locations within the region, and the 33 total positions of his department. He reviewed the different units within the office and their areas of focus, along with statistics for the referrals received, cases covered, and trials undertaken in the previous year. J. Dallaire noted that they work with multiple law enforcement agencies but highlighted some of the key cases involving the Fairbanks Police Department (FPD). He stated he is aware of the issues in the downtown area, that he has been meeting with the Mayor and Chief of Police, and that he will be meeting with post office officials soon regarding the concerns he has been hearing about.

Mr. Cleworth asked J. Dallaire if his office deals with matters of guardianship. J. Dallaire explained that the DA's office strictly covers criminal prosecutions and that the only involvement it would have with matters of guardianship would be the beginning steps of a civil commitment for someone who had been deemed mentally incompetent and unable to stand trial. He indicated that the Attorney General's office would be the agency that handles guardianship cases.

Mayor Pruhs asked J. Dallaire if he could attend the meeting with post office officials that had been mentioned. J. Dallaire stated that the Mayor would be welcome to join them.

Mr. Marney thanked J. Dallaire for his local involvement and dedication to his position.

Ms. Therrien asked J. Dallaire if he has any coordination with Native organizations for criminal prosecution deferrals. J. Dallaire shared that his office maintains relationships with the various Native organizations but that the majority of their referrals are in coordination with the Fairbanks Community Restorative Justice Program at the University of Alaska Fairbanks, which is primarily for lower-level offenses. He noted that these individuals are often able to work with the program to seek resolutions and that most of the cases ultimately get dismissed.

Mayor Pruhs invited City Engineer Robert Pristash and Public Works Director Jeremiah Cotter to give an update on City streetlights and other items.

J. Cotter reported that an issue was discovered with an electrical box located on Eighth Avenue between Lacey and Noble Streets which had been causing outages for a large area. He shared that he had come into town on a Saturday to look for locations with issues, giving a heads up to the City's contractor that handles street lighting work. He reported that Star Electric had been responsive and was able to diagnose the issue and get the units working again. Mayor Pruhs asked for details on a permanent fix to the problem. R. Pristash explained that light sensors have been used for a long time to tell the streetlight units across the City when to turn on or off but that ten years prior they had opted to use a new, computerized system that would override the light cells and dictate operation schedules. He shared that the new system was supposed to save money but ultimately proved to be overcomplicated and the City chose to abandon it. He stated that despite disconnecting those components years ago, upon seeing photos referenced by J. Cotter he noticed a unit that was part of the old system. He explained that they discovered the unit had a battery which was somehow still holding a charge and interfering with the system in place. He indicated that an ideal solution would be to open the box, completely remove all remnants of the abandoned system, and install newer photocell sensors, which should fix the issues.

Ms. Sprinkle asked if this would also explain why the streetlights in her neighborhood never turn off. R. Pristash stated that the load centers across the City have switches that can be set to automatic or manual and that if they are having problems with sensors activating lights, they will usually switch the system to manual and let the lights burn constantly until they resolve the sensor issues.

Mr. Cleworth stated that he was under the impression that they were using an automated system that told the lights when to turn on and off based on the day of the year and available sunlight data. R. Pristash confirmed that was the system he had referenced, which never ended up working the way it was supposed to. He added that the problem they are finding is that remnants of the old system are interfering with what is in place now.

Mayor Pruhs thanked staff for their reports and expressed appreciation for Public Works taking care of street conditions over the weekend. J. Cotter added his gratitude for those employees who had been willing to come in on their days off to help take care of urgent needs.

Mayor Pruhs discussed the shooting that occurred outside the Midnight Mine and stated that he had been in communication with those involved late that night and into the next morning. He commended the FPD officers and the dispatchers who coordinated getting the suspect into custody. He shared that the owner of the bar reached out to him to ask if he would meet with the mother of the deceased, which he did. He indicated that while it was not easy, it was a good meeting. He shared that the mother requested to meet with and thank the City staff who were integral in seeing the suspect apprehended. Mayor Pruhs declared that in a time of tragedy, the best came out of in the worst of circumstances.

COUNCILMEMBERS' COMMENTS

Ms. Therrien indicated that she would defer to the second round of Councilmember Comments.

Ms. Tidwell shared that she had attended the recent annual "Guns and Hoses" hockey game between local police and firefighters and that it was a great game.

Mr. Marney thanked J. Cotter for the efforts of Public Works. He thanked the Mayor for being involved with the recent murder incident. He commended the dispatcher who took action, using their available resources during a pivotal moment which ultimately led to FPD locating the suspect. He reported that he had reached out to Senator Dan Sullivan's office to discuss the problems with the downtown post office, as he understands it to be under federal jurisdiction. He asserted that FPD will always take care of the community but felt that others may need to be part of the solution.

Ms. Sprinkle expressed appreciation for the DA's office plan to meet with post office officials.

Mr. Cleworth thanked J. Cotter for his crew's work over the weekend and stated that he felt safe on the roads despite the conditions. He expressed appreciation for B. Nikolaides sharing his concerns and concurred that downtown business owners have unique challenges. He discussed people being trespassed multiple times, resulting in arrests, which does not seem to fix the problem as they are usually back on the street in 24 hours. He stated that is why he asked the DA about guardianship proceedings. Mr. Cleworth recounted that no concrete solutions have been found despite decades of the same issues and suggested that there needs to be a better legal hammer to address chronic public intoxication offenses. He added that there are also situations where people with mental illness create disturbances which affect businesses downtown; he added that those individuals can be more dangerous. He admitted that he does not have answers to these challenges but noted that they are all aware of the significance of the problem. Mr. Cleworth asked what tools could be available to business owners to deal with those types of situations other than the unproductive options currently being used. He wished the Mayor luck in seeking viable solutions. Mayor Pruhs indicated that he intends to be quite aggressive with how to handle these problems.

Mr. Cleworth asked for clarification on some of the updated language regarding the proration of fees for licenses issued midyear as well as the timing of renewals. City Attorney Thomas Chard explained that the purpose of the ordinance was to correct an oversight in conflicting parameters and language pertaining to the timing of license renewals. He clarified that only those obtaining a license for the first time would receive any proration of fees. He provided an example to illustrate how the process would work with the corrected language in the ordinance.

Mr. Cleworth, seconded by Ms. Sprinkle, moved to ADVANCE Ordinance No. 6304.

Mr. Cleworth asked for clarification on whether Section 54-39(b) had been correctly notated. Clerk Snider explained that the language of the new Sec. 54-39(b) currently existed within the previous subsection and was being separated into a new subsection (b). She stated the subsections to follow were updated accordingly.

Mr. Cleworth asked if other parts of the Fairbanks General Code (FGC) place restrictions on the sale or disposal of certain surplus property, such as evidence from FPD or firearms, which would not be subject to the allowances for disposal provided to the Purchasing Agent. Attorney Chard

confirmed that a separate section of FGC addresses those types of situations, and he indicated that it may be prudent to include additional language referencing those items. **Mayor Pruhs** suggested that the issue be discussed at the next work session.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO ADVANCE ORDINANCE NO. 6304 AS FOLLOWS:

Mayor Pruhs declared MOTION CARRIED.

g) Ordinance No. 6305 – An Ordinance Amending Fairbanks General Code Section 70-162, to Ensure Visible and Safe Traffic Intersections and Amending the City Schedule of Fees and Charges for Services. Introduced by Mayor Pruhs.

Ms. Sprinkle, seconded by Mr. Marney, moved to ADVANCE Ordinance No. 6305.

Mr. Cleworth pointed out that the heading for Sec. 70-162 only references regulations for "planting" but that some of the added language within the section addresses obstructions other than foliage. He suggested that if he was looking for information about fencing regulations, he would skip past that section once he read the title. Mayor Pruhs stated that he would work with the City Engineer and Attorney to resolve the issue and asked Mr. Cleworth to email him a list of things he had made note of within the ordinance. Mr. Cleworth shared an experience of an appeal process for a property owner off Cowles Street who was being directed to move an obstructing fence. He stated that the owner appealed the ruling due to the fence being in place since Alaska's territorial days. Mayor Pruhs acknowledged that grandfathering exemptions is common. Mr. Cleworth explained that the City can get itself into trouble if there is not language to address what can be grandfathered, and he also mentioned Borough standards. He asserted that he would have a problem going after someone's fence if it had been unchanged for decades. Mayor Pruhs concurred that those are important issues and committed to having more details by the next work session. He indicated that having a clear appeal process, plus checks and balances, is important anytime the City is dealing with private property.

h) Ordinance No. 6306 – An Ordinance Amending Fairbanks General Code Section 70-161 and the Local Amendments to the 2018 International Fire Code Adopted by Reference at Fairbanks General Code Section 30-32, and Amending the City Schedule of Fees and Charges for Services to Ensure Access to Fire Hydrants. Introduced by Mayor Pruhs.

Ms. Therrien, seconded by Mr. Cleworth, moved to ADVANCE Ordinance No. 6306.

Mr. Cleworth addressed the firm language of the newly added Sec. 70-161(e) which indicates that an individual would have only 24 hours to rectify the situation described therein. He suggested that that is a tight window for many people to correct matters of snow and ice placement and that there does not appear to be any discretion provided to the Director of Public Works. **Mayor Pruhs** agreed that there must be a standard but with reasonable flexibility.

i) Ordinance No. 6307 – An Ordinance Reestablishing the Incentive Bonus Program with the Fairbanks Police Department for Recruitment and Hiring. Introduced by Mayor Pruhs.

ADVANCED ON THE CONSENT AGENDA

j) Ordinance No. 6308 – An Ordinance Reestablishing the Incentive Bonus Program with the Fairbanks Emergency Communications Center for Recruitment and Hiring. Introduced by Mayor Pruhs.

Ms. Sprinkle, seconded by Mr. Marney, moved to ADVANCE Ordinance No. 6308.

Mr. Marney expressed concern with the provision of the sign-on bonus being available to former staff members after only a 12-month absence from employment with the Fairbanks Emergency Communications Center (FECC). He added that the second half of the bonus being paid upon completion of a probationary period is much earlier than the similar incentive offered to police officers. He suggested that the bonus might not help with retention problems. Chief of Staff Michael Sanders highlighted language which stated that no individual could receive the bonus more than once – the same language that was in place when the program was installed. Mr. Marney indicated that he would like to see something to better address retention.

Ms. Tidwell noted that the attached agreement included a provision that the employee would stay for at least three years and that leaving prior to that would require a prorated payback of the bonus. **Mr.** Marney agreed that this was an adequate way to address the issue.

Mr. Cleworth concurred that the FPD incentive program differs from the FECC one in that police officers would receive their second half of the bonus after three years whereas dispatchers receive theirs after completing their probationary period, which is about nine months after hire. He recounted that the FPD program had initially included a longer threshold but eventually was settled on three years. He agreed that if they wanted to focus on retention, a longer stretch of time might be appropriate to receive the second half of the bonus.

M. Sanders pointed out that the FPD bonus was \$60,000 compared to \$15,000 for FECC. He suggested waiting three years for another \$30,000 makes more sense than doing so for \$7,500. **Mr. Marney** acknowledged that it would likely not be as effective and may even have a negative

effect. He noted that the existing program seems to be working, with six individuals being hired since implementation and with four of those remaining with the FECC. He pointed out that the FPD has seen about a 50% retention rate.

COMMITTEE REPORTS AND COUNCILMEMBERS' COMMENTS

Ms. Therrien reported that the Legislative Committee recently met. She shared several items that had been discussed plus notes on the current legislative session in Juneau, including:

- The legislature is coming into an existing deficit of \$1.5 billion.
- It is unclear if the State can use the Constitutional Budget Reserve to address the deficit.
- The legislature is hoping for a supplemental appropriation for municipal assistance.
- Without a supplemental appropriation, the City of Fairbanks will likely receive around \$80,000 instead of \$400,000 to \$500,000.
- M. Sanders will be working on the City's capital requests to be addressed in March.
- An alternative categorization for the criminal charge of spitting on a public safety officer is being reviewed.
- Mayor Pruhs plans to travel to Juneau in February and April, and she plans to go in March.
- The Permanent Fund Dividend will likely be around \$1,000.
- A fairly flat budget, with a modest capital budget, is expected.

Ms. Therrien shared that she had emailed notes for her three days of attendance at the Alaska Municipal League (AML) conference in December. She added that she would like to focus on working with the various Native organizations in Fairbanks to coordinate mutual funding efforts to address problems within the community.

Mr. Cleworth discussed a recent letter that had been forwarded by the City Clerk from the Chena Riverfront Commission, which addressed the difficulty in coming to an agreement with the Alaska Railroad regarding the long-pursued bike path project. He shared that he had also received communication from the railroad to the Fairbanks Area Surface Transportation (FAST) Planning Policy Board, which he chairs. He explained that both the State of Alaska Department of Transportation (DOT) and the Alaska Railroad have different sets of requirements and regulations that appear to be in conflict for the proposed project. He stated that the Chena Riverfront Commission has essentially appealed to the leadership of both organizations to find a way to work through the issues for the benefit of the community. Mayor Pruhs shared that he has been involved with the project for about 30 years and that it is apparent that it will only be able to move forward with a land purchase. Mr. Cleworth acknowledged that the Alaska Railroad was given land such as this to allow it to have assets to ensure continued healthy operation and that if the organization were to consider selling that stretch of riverfront property, it would profit far more by selling it for residential property development. He pointed out that if the railroad was required to get an assessment of the property value based on what could be done with it, it is unlikely that the State would be able to afford the purchase, given the potential it has beyond a bike path.

Ms. Sprinkle reported that the Chena Riverfront Commission recently met and that the bike path had been a significant topic of discussion, as it has been since the late 1980s. She admitted that it is a messy issue and expressed hope that a solution can be found. She shared that the Chamber of Commerce Board of Directors had also met, with the current focus being on the fly-in to Juneau to advocate for the issues of major concern to the Fairbanks community.

Mayor Pruhs addressed Mr. Ringstad's absence and shared that they had spoken on the phone regarding a current family obligation. He stated that he had excused Mr. Ringstad's absence.

Mr. Marney discussed the issues raised by B. Nikolaides about the downtown post office and encouraged him to take B. Butler up on her offer to assist the next time there is a situation. He spoke highly of B. Butler's efforts and success in helping with various difficult situations in the community. B. Nikolaides thanked him for the recommendation and committed to doing so.

Ms. Tidwell stated that she did not have any committee reports but shared that the Economic Development Commission would be meeting soon and would hear a presentation from the Fairbanks Economic Development Commission regarding their effort to become the Alaska Regional Development Organization for the region. She reported that she would also be traveling to Juneau in February and would be happy to meet with Ms. Therrien to discuss how she could further support efforts to promote the legislative priorities the Council had established for 2025.

Mayor Pruhs thanked Ms. Tidwell for her service on the Fairbanks North Star Borough Planning Commission. He stated that Olivia Rodriguez had been appointed to fill Ms. Tidwell's seat.

CITY CLERK'S REPORT

Clerk Snider reported that registration for the upcoming Citizen Engagement Academy has been successful, that the 2025 class is full, and that people may still apply to be added to the waiting list. She indicated that the Mayor had made a request for the Council to consider moving the Regular Meeting of March 10, 2025 to March 17. **Mayor Pruhs** explained that he will be traveling to Washington, D.C. and that the week of March 10 was the most ideal time for the trip. He stated that if the date change was problematic for others, they could keep the original date and have Mr. Cleworth chair the meeting in his absence. Clerk Snider clarified that any change to the approved meeting schedule would need to be done by motion with a majority vote.

CITY ATTORNEY'S REPORT

Attorney Chard indicated that he had nothing to report and thanked the Councilmembers for their service to the community.

Ms. Therrien asked if there was an update to the potential change of venue for an upcoming litigation. **Mayor Pruhs** responded that the issue was a confidential topic meant for Executive Session discussion only. Attorney Chard invited Ms. Therrien to reach out to him directly if she would like an update on the matter.

ADJOURNMENT

Ms. Tidwell, seconded by Ms. Sprinkle, moved to ADJOURN the meeting.

Mayor Pruhs called for objection and, hearing none, so ORDERED.

Mayor Pruhs declared the meeting adjourned at 8:00 p.m.



AN ORDINANCE AMENDING FAIRBANKS GENERAL CODE CHAPTER 54 PROCUREMENT, SECTIONS 54-39 AND 54-241, TO CLARIFY THE COUNCIL NOTIFICATION REQUIREMENT FOR SOLE SOURCE PURCHASING

WHEREAS, Fairbanks General Code Sec. 54-39(a) gives authority to the purchasing agent to award contracts in the amount of \$50,000 or less and specifies that the purchasing agent must notify the Council of such awards when competitive bidding is not deemed possible; and

WHEREAS, Fairbanks General Code Sec. 54-39(c) gives authority to the mayor to award contracts in the amount of \$250,000 or less; and

WHEREAS, Fairbanks General Code Sec. 54-39(d) states that all other contracts may be awarded by the City Council and that, when competitive bidding is not deemed possible, the Council will cite the reasons why in the resolution for award; and

WHEREAS, all sole source contracts awards made by the purchaing agent or the mayor should be reported to the City Council on a regular basis, and the report should include a citing of the reasons and findings.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

<u>Section 1.</u> That Fairbanks General Code Section 54-39 Contract award authority, is hereby amended as follows [new text in <u>bold/underline</u> font; deleted text in <u>strikethrough</u> font]:

Sec. 54-39. - Contract award authority.

- (a) The purchasing agent may award contracts funded with identifiable appropriations made by the city council when the amount is \$50,000.00 or less, provided the purchasing agent notifies the city council when competitive bidding is not deemed to be possible and recite the reasons and findings.
- **(b)** The purchasing agent may award the sale, trade, or disposal of all personal property which has become surplus, obsolete, or unusable.
- (cb) The mayor may award contracts funded with identifiable appropriations made by the city council when the contract amount is \$250,000.00 or less.
- (de) The city council may award all other contracts. When competitive bidding is not deemed to be possible, the city council shall, in the resolution for award, recite the reasons why.

<u>Section 2.</u> That Fairbanks General Code Section 54-241 Sole source purchasing, is hereby amended as follows [new text in <u>bold/underline</u> font; deleted text in <u>strikethrough</u> font]:

Sec. 54-241. - Sole-source purchasing.

- (a) A contract may be awarded for supplies, services, professional services or construction without competitive sealed bidding, competitive sealed proposals or other competition in accordance with this article. A contract may be awarded under this section only when the purchasing agent determines in writing that there is only one source for the required purchasing or construction. A sole-source purchase may not be made if a reasonable alternative source exists. The written determination must include findings which support the determination that only one source exists. The authority to make the determination and findings required by this subsection may not be delegated.
- (b) The using department shall submit written evidence to support a sole-source determination. The purchasing agent may also require the submission of cost or pricing data in connection with an award under this section.
- (c) The purchasing agent shall negotiate with the single supplier, to the extent practicable, to obtain the most advantageous contract to the city.
- (d) The purchasing agent must provide a quarterly report to the city council of all sole source purchases made in the amount of \$250,000 or less when competitive bidding is not deemed possible and recite the reasons and findings.

Section 3. That the effective date of this ordinance is six days after adoption.

WHEREAS, Fairbanks General Code Sec. 54-39(d) states that all other contracts may be awarded by the City Council and that, when competitive bidding is not deemed possible, the Council will cite the reasons why in the resolution for award; and

WHEREAS, all sole source contracts awards made by the <u>purchasing</u> agent or the mayor should be reported to the City Council on a regular basis, and the report should include a citing of the reasons and findings.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

<u>Section 1.</u> That Fairbanks General Code Section 54-39 Contract award authority, is hereby amended as follows [new text in <u>bold/underline</u> font; deleted text in <u>strikethrough</u> font]:

Sec. 54-39. - Contract award authority.

- (a) The purchasing agent may award contracts funded with identifiable appropriations made by the city council when the amount is \$50,000.00 or less, provided the purchasing agent notifies the city council when competitive bidding is not deemed to be possible and recite the reasons and findings.
- **(b)** Unless otherwise provided by law, <u>Tt</u>he purchasing agent may award the sale, trade, or <u>disposal</u> <u>dispose</u> of all personal property which has become surplus, obsolete, or unusable.
- (cb) The mayor may award contracts funded with identifiable appropriations made by the city council when the contract amount is \$250,000.00 or less.
- (de) The city council may award all other contracts. When competitive bidding is not deemed to be possible, the city council shall, in the resolution for award, recite the reasons why.

<u>Section 2.</u> That Fairbanks General Code Section 54-241 Sole source purchasing, is hereby amended as follows [new text in <u>bold/underline</u> font; deleted text in <u>strikethrough</u> font]:

Sec. 54-241. - Sole-source purchasing.

- (a) A contract may be awarded for supplies, services, professional services or construction without competitive sealed bidding, competitive sealed proposals or other competition in accordance with this article. A contract may be awarded under this section only when the purchasing agent determines in writing that there is only one source for the required purchasing or construction. A sole-source purchase may not be made if a reasonable alternative source exists. The written determination must include findings which support the determination that only one source exists. The authority to make the determination and findings required by this subsection may not be delegated.
- (b) The using department shall submit written evidence to support a sole-source determination. The purchasing agent may also require the submission of cost or pricing data in connection with an award under this section.
- (c) The purchasing agent shall negotiate with the single supplier, to the extent practicable, to obtain the most advantageous contract to the city.
- (d) The purchasing agent must provide a quarterly report to the city council of all sole-source purchases made in the amount of \$250,000 or less when competitive bidding is not deemed possible and recite the reasons and findings.

Section 3. That the effective date of this ordinance is six days after adoption.

ORDINANCE NO. 6305

AN ORDINANCE AMENDING FAIRBANKS GENERAL CODE, SECTION 70-162, TO ENSURE VISIBLE AND SAFE TRAFFIC INTERSECTIONS AND AMENDING THE CITY SCHEDULE OF FEES AND CHARGES FOR SERVICES

WHEREAS, the City Engineer has jurisdiction over intersectional sight lines at traffic intersections within the city limits; and

WHEREAS, there is currently no fee in the City's Schedule of Fees and Charges for Services to charge property owners in violation of obscuring intersectional sight lines; and

WHEREAS, adding a fee to the City's Schedule of Fees and Charges for Services will help the City recover its costs to remove such obstructions and will help ensure visible and safe traffic intersections.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

<u>Section 1</u>. Fairbanks General Code Chapter 70, Article IV Public Streets, Section 70-162 Regulation for planting in a public place is hereby amended, as follows [new text in <u>bold/underline</u> font; deleted text in <u>strikethrough</u> font]:

Sec. 70-162. - Regulation for planting in or near a public place.

- (a) *Trimming, treating.* It shall be the duty of any person growing trees or plants that impact the public highway or right-of-way or who is responsible for trees or plants growing on property abutting on public places to:
 - (1) Trim trees or plants so as not to cause a hazard to the public, such as impacting intersection sight distance or obscuring traffic signs, or interfering with the proper public lighting or street lighting;
 - (2) To treat or remove any tree or plant which creates a nuisance or is a hazard to any public place by reason of being <u>damaged</u>, diseased or insect ridden.

(b) Setback.

(1) Street. On a corner lot, trees, or plants within the sight triangular area, as determined by the city engineer, must be planted and maintained in such a manner as to not impact sight distance at intersections and compromise the safety of the traveling public. Trees and plants that impact sight distance at intersections and compromise the safety of the

- traveling public by impacting sight distance or obscuring signs must be removed as directed by the city engineer.
- (2) Sidewalk. No tree or plant may be planted in the green space between the sidewalk and the curb.
- (be) The city engineer is authorized to direct the person who is responsible for trees or plants growing on property abutting en-public places to trim, treat, or remove any tree or plant so as to comply with subsection (a). If the person responsible for such trees or plants fails to comply, the city engineer may arrange for the removal of such trees or plants. The cost of such trimming, treating, or removal will be charged to the person responsible, provided the person responsible fails to do so after having received notice from the city engineer. The cost of trimming, treating, or removing any tree or plant under this subsection will be set forth in the city schedule of fees and charges for services. The person, so directed, may appeal the city engineer's direction to the mayor within seven days of the issuance of the notice from the city engineer.
- (<u>c</u>d) For purposes of this section, a person is responsible for an trees and plants if they are the owner, <u>manager</u>, or occupant of the premises abutting the roadway or right-of-way.

(d) Setback.

- (1) Street. On a corner lot, trees, or plants any obstruction blocking sight within the sight triangular area, as determined by the city engineer, is a hazard and must be planted and maintained in such a manner as removed to not impact interfere with sight distance at intersections and compromise the safety of the traveling public. Items including, but not limited to, trees, and plants, snow, large vehicles, construction materials, and debris that impact sight distance at intersections and compromise the safety of the traveling public by impacting sight distance or obscuring signs must be removed as directed by the city engineer.
- (2) Sidewalk. No tree or plant may be planted in the green space between the sidewalk and the curb.
- (3) The city engineer is authorized to direct the person who is responsible for any obstruction as described in this subsection to remove the obstruction. The person, so directed, may appeal the city engineer's direction to the mayor within seven days of the issuance of the notice from the city engineer.
- (e) Unless the mayor directs otherwise, if the person responsible for a hazardous tree or plant or a hazardous obstruction, both described in this section, fails to comply after the city engineer has provided notice,

the city engineer may arrange for the remediation or removal of the hazard. The cost of such remediation or removal will be charged to the person responsible. The person responsible may appeal said charge to the mayor within 14 days after notice of the charge has been issued. The mayor may waive charges in whole or in part.

(f) The cost of remediating and removing hazards under this section will be set forth in the city schedule of fees and charges for services.

<u>Section 2</u>. The Engineering section of the *City Schedule of Fees and Charges for Services* is hereby amended according to Attachment A to this ordinance.

Section 3. The effective date of this ordinance is six days after adoption.

WHEREAS, adding a fee to the City's Schedule of Fees and Charges for Services will help the City recover its costs to remove the obstruction and will help ensure fire hydrants remain accessible.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

Section 1. Fairbanks General Code Chapter 70, Article IV Public Streets, Section 70-161 Snow and ice; removal; standing; casting on public property is hereby amended, as follows [new text in **bold/underline** font; deleted text in strikethrough font]:

Sec. 70-161. - Snow and ice; removal; standing; casting on public property.

- (a) A person having control of any premises bordered by a graded or paved sidewalk must promptly remove any snow which falls on the sidewalk and must remove or sand any ice which forms on the sidewalk, to the extent that the snow or ice is an impediment to pedestrians.
- (b) It is unlawful for any person to move snow or ice from private property or to hire, direct, or allow another person to move snow or ice from private property onto any sidewalk, street, avenue, or alley in the city to the extent that the snow or ice is an impediment to use of the sidewalk, street, avenue, or alley.

 or fire hydrant. It is not a violation of this subsection to move snow from a sidewalk into the adjacent street.
- (c) A person violating subsection (b) above is guilty of a minor offense. A person charged with violating subsection (b) must respond to the city clerk's office within 30 days of receipt of the citation. - (e) The director of public works, or designee, is authorized to direct the removal of any snow or ice that was taken from private property and moved to a sidewalk, street, avenue, alley, or a place obstructing access to a fire hydrant. The cost of such removal will be the responsibility of the owner of the property from which the snow or ice was moved, provided the owner or person having control of the premises fails to remove the snow or ice in a manner satisfactory to the director of public works, or their designee, within 24 hours after having received notice from the director of public works.
- (f) Costs of removal of any snow or ice done at the direction of the director of public works, or designee, under this section shall be set forth in the city schedule of fees and charges for services.
- (g) Any person charged with snow or ice removal costs under subsections
 (d) or (e) of this section may seek relief from the city mayor who may waive charges in whole or in part. Any person not satisfied with the mayor's decision, may appeal to the city council within 30 days from the mayor's decision.
- (eh) For purposes of this section, a person has control of a premises if they are the owner, manager, or occupant of the premises.

<u>Section 2</u>. The City of Fairbanks Local Amendments to the 2018 International Fire Code, adopted by reference in Fairbanks General Code at Section 30-32, is hereby amended as follows [new text in <u>bold/underline</u> font; deleted text in <u>strikethrough</u> font]:

SECTION 507 FIRE PROTECTION WATER SUPPLIES

507.5.4 Obstruction. Unobstructed access to fire hydrants, fire department inlet connections (FDC), or fire protection system control valves shall be maintained at

all times. The fire department shall not be deterred or hindered from gaining immediate access to fire protection equipment or fire hydrants. Posts, fences, vehicles, growth, trash, storage, **snow**, and other materials or objects shall not be placed or kept near fire hydrants, FDC, or fire protection system control valves in a manner that would prevent such equipment from being immediately discernible **or would impede immediate access**. No vehicle shall be parked within 15 feet in front of, and 4015 feet to the side of a fire hydrant, FDC, or fire protection control valve on private or public property.

Section 3. The effective date of this ordinance is six days after adoption.

SECTION 507 FIRE PROTECTION WATER SUPPLIES

507.5.4 Obstruction. Unobstructed access to fire hydrants, fire department inlet connections (FDC), or fire protection system control valves shall be maintained at all times. The fire department shall not be deterred or hindered from gaining immediate access to fire protection equipment or fire hydrants. Posts, fences, vehicles, growth, trash, storage, **snow**, and other materials or objects shall not be placed or kept near fire hydrants, FDC, or fire protection system control valves in a manner that would prevent such equipment from being immediately discernible **or would impede immediate access**. No vehicle shall be parked within 15 feet in front of, and **1015** feet to the side of a fire hydrant, FDC, or fire protection control valve on private or public property.

Section 3. The effective date of this ordinance is six days after adoption.

ORDINANCE NO. 6307

AN ORDINANCE REESTABLISHING AN INCENTIVE BONUS PROGRAM WITH THE FAIRBANKS POLICE DEPARTMENT FOR RECRUITMENT AND HIRING

WHEREAS, an incentive bonus program for recruitment and hiring at the Fairbanks Police Department (FPD) was established by the City Council on June 19, 2017, with the adoption of Ordinance No. 6050, reestablished by Ordinance No. 6129 in April 2020, amended by Ordinance No. 6248 in June 2023, and expanded to include first-time law enforcement officers in November 2023 by Ordinance No. 6266; and

WHEREAS, the reasons for continuing to provide a bonus to lateral hires are: (1) to avoid the high cost for the City to send an officer to the Police Academy (approximately \$50,000); and (2) that a one-time, sign-on bonus of \$60,000 for a lateral hire would help attract applicants and would be competitive with other municipalities; and

WHEREAS, the City would like to encourage individuals, especially citizens of the city, to begin a career in law enforcement; and

WHEREAS, the incentive bonus program has been instrumental in recruiting lateral-hire personnel and first-time law enforcement officers; and

WHEREAS, the FPD continues to have a need for the incentive bonus program.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows.

SECTION 1. The incentive bonus program for recruitment and hiring within the Fairbanks Police Department is hereby reestablished as follows:

- (a) An applicant who is a certified police officer in the State of Alaska or is able to meet Alaska Police Standards Council (APSC) certification standards without attending a basic officer academy will be paid a \$60,000 "sign-on bonus." The city will pay 50% in their first paycheck following completion of Field Training and 50% after three years of service, subject to the payback provisions specified in the attached Signon Bonus Agreement. No applicant may receive a sign-on bonus more than once, and no applicant may receive a sign-on bonus if they have previously been employed by the Fairbanks Police Department within 12 months of rehire.
- (b) An applicant without prior law enforcement certification from the Alaska Police Standards Council, or similar organization in another state, who successfully completes the basic officer academy and field training, will

be paid a \$20,000 "sign-on bonus." The City will pay \$10,000 of the bonus to the employee in their first paycheck following completion of field training and the remaining \$10,000 after 24 months of employment as a police officer. No employee may receive a sign-on bonus more than once.

(c) If an active city employee recruits a new officer, as defined in subsection (a) or (b), who successfully completes the hiring process, the employee will receive a recruitment bonus of \$5,000. The recruitment bonus does not apply to employees with duties that are related to recruitment or hiring.

SECTION 2. The Sign-on Bonus Agreements (Attachment A and Attachment B) are approved.

SECTION 3. Bonuses will be funded through savings from budgeted salaries, as available.

SECTION 4. This program will sunset on December 31, 2026 unless extended by resolution of the City Council.

SECTION 5. The effective date of this ordinance is six days after adoption.

Taxes shall be withheld as bonus earnings from the Sign-on Bonus and reported to the Internal Revenue Services as income on the Employee's Form W-2. The Sign-on Bonus is not considered "salary" and shall not be included for purposes of retirement benefit calculations or salary increases.
- 3. The Department will adhere to all relevant City and Department policies during the hiring process and in making bonus payments to employees.
- 4. In return for accepting the Sign-on Bonus as provided in paragraphs 1 and 2 above, the Employee agrees to work for the Department on a regular and full-time basis for at least five years beginning "Start Date" and ending on "5 Year Date." The second payment of the remaining "sign-on" bonus will be paid with the first paycheck after completing the probation period, subject to the payback provisions specified in the attached Sign-on Bonus Agreement. No applicant may receive a sign-on bonus more than once, and no applicant may receive a sign-on bonus if they have previously been employed by the Fairbanks Emergency Communications Center within 12 months of rehire.
- (b) If an active City of Fairbanks employee recruits a new dispatcher (as defined in section (a) who successfully completes the training process and probationary period, the employee will receive a recruitment bonus of \$5,000. RESOLUTION NO. 5163

A RESOLUTION URGING THE STATE OF ALASKA TO HONOR ITS COMMITMENT TO CAP PAST AND PRESENT PERS SERVICE COSTS FOR MUNICIPAL EMPLOYERS AT 22 PERCENT

WHEREAS, the State of Alaska created the Public Employees' Retirement System (PERS) in 1961 to provide a retirement system for state and participating municipal employees; and

- **WHEREAS**, since its creation, PERS has evolved from being fully funded to being underfunded by billions of dollars; and
- **WHEREAS**, the City of Fairbanks participated in PERS, but has never had managerial control of PERS; and
- **WHEREAS**, the State Legislature passed SB 125 in 2008 to address the unfunded liability, which modified AS 39.35.255 to establish an employer rate of 22% for PERS non-state employers; and
- **WHEREAS**, the City of Fairbanks supported SB 125 and expressed that support through Resolution No. 4274; and
- **WHEREAS**, since that time, PERS employers have paid \$7.7 billion toward the unfunded liability; and
- **WHEREAS**, the recently introduced SB 81 could potentially increase contribution rates beyond 22% to liquidate past liabilities; and
- **WHEREAS**, an increase to the contribution rate will have significant impacts on municipalities and other non-state PERS employers; and
- **WHEREAS**, maintaining the currently established PERS contribution rate remains the City's top legislative priority, because an increase in the employer rate would create a financial burden on all local governments throughout the state and will result in a reduction of public services and jeopardize local infrastructure improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

SECTION 1. The Fairbanks City Council urges the Alaska State Legislature to continue to honor its commitment to cap past and present service costs for municipal PERS employers at the current rate of 22 percent.

SECTION 2. The City Clerk is directed to provide the Interior Delegation with an executed copy of this resolution.

SECTION 3. The effective date of this resolution is six days after adoption.

ORDINANCE NO. 6310

AN ORDINANCE AUTHORIZING THE LEASE OF OFFICE SPACE IN CITY HALL TO THE DENALI COMMISSION

WHEREAS, Per Fairbanks General Code, Section 70-42(c), a lease may be executed prior to the expiration of the 30-day period provided for voter referendum if the lease is made explicitly subject to the referendum; and

WHEREAS, the Denali Commission approached the City of Fairbanks inquiring about potentially leasing office space from the City in City Hall; and

WHEREAS, the Denali Commission is an independent federal agency designed to provide critical utilities, infrastructure, and economic support throughout Alaska; and

WHEREAS, available space has been identified in the Building Department that would meet the Denali Commission's need and would not interfere with the Building Department's regular operations.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

<u>Section 1</u>. The Mayor is authorized to enter into an agreement with the Denali Commission to lease office space in City Hall for a period not to exceed five years.

<u>Section 2</u>. The lease agreement must be made subject to the permissive referendum process.

Section 3. The effective date of this ordinance is six days after adoption.

City of Fairbanks Permanent Fund Review Board Quarterly Meeting Minutes October 23, 2024

The Permanent Fund Review Board (PFRB) convened at 1:32 p.m. in the Felix Pedro Conference Room to conduct a quarterly meeting.

Vice Chair Gatewood asked if any opposed approval of the meeting minutes from the July 24, 2024, none opposed.

Margarita Bell reviewed the account's performance through September 30, 2024:

- \$159,603,183 Balance including accrued income
- \$ 2,314,185 Dividends and interest earnings
- \$ 1,597,207 Realized gain
- \$ 13,171,753 Unrealized gain
- \$ (76,712) Management and custodial fees
- \$ 17,006,433 Earnings, net of expenses

Margarita Bell reported that the annual draw will be made in December 2024 in the amount of \$6,374,346 to the general fund (\$5,666,085) and capital fund (\$708,261). She stated that she will coordinate with APCM (Alaska Permanent Capital Management) prior to withdrawing the funds.

Blake Phillips reported that the balance of the fund was \$159.1 million.

Brandy Niclai presented an account summary as of September 30, 2024. She stated that the inception annualized account return is 5.72% and that the annualized account return as of March 2017 is 7.12%. She stated that diversification is enhancing the portfolio beyond the traditional stock and bond portfolio. Since inception, the portfolio had contributions of \$111.4 million, withdrawals of \$123.0 million, and earnings of \$171.2 million.

Brandy Niclai presented a market and portfolio review for the third quarter. The economic growth and inflation are slowing but recent returns have been positive by maintaining long-term equity targets such as high-quality large capitalization stock. The portfolio volatility has been within expectations. The outperformance in the third quarter was driven by alternative beta. The combined equity and alternatives allocation returned 7.2% and the combined fixed income allocation returned 4.5% for the quarter.

APPROVAL OF REGULAR MEETING MINUTES

- a) Regular Meeting Minutes of November 6, 2024
- G. Dalton, seconded by A. Stratman, moved to APPROVE the November 6, 2024 minutes.

Chair Kilbourn took a voice vote on the motion to APPROVE the November 6, 2024 minutes and all members voted in favor.

APPROVAL OF AGENDA

J. Richardson, seconded by A. Stratman, moved to APPROVE the agenda.

Chair Kilbourn took a voice vote on the motion to APPROVE the agenda and all members voted in favor.

<u>CITIZENS COMMENTS</u> – None

COMMUNICATIONS TO COMMISSION – None

EVENTS & PUBLIC RELATIONS

Chair Kilbourn suggested that it was too early to set a date for their annual cleanup event in May.

FINANCIAL UPDATE

Chair Kilbourn referenced the financial report and affirmed that their current account balance is \$2,606.10. Deputy City Clerk Colt Chase confirmed that there were no outstanding expenses.

UNFINISHED BUSINESS

a) Quiring Monument Orders

Chair Kilbourn shared that J. Jones had emailed a status update on the Quiring orders. She reported that their current submission to Quiring had already gone through two rounds of proofing with J. Richardson and will hopefully be correct by the end of the third round. **J. Richardson** confirmed that she had sent her most recent notes to the company back in November and had not yet heard anything back. **Chair Kilbourn** added that J. Jone's report had also noted that 100 total concrete pads had been paid for with Fairbanks Precast and will be ready to be picked up by Public Works come springtime.

b) Communication with Blanchard Funeral Home re: P. Cathey's Burial at CSC

Chair Kilbourn shared that she had received a letter from Patricia Cathey with an update on the arrangements being made for her future placement and that they had spoken on the phone earlier that morning. She stated that she had also spoken with Keith Blanchard who was under the impression that P. Cathey had already passed away. She indicated that P. Cathey was a little frustrated with the confusion and asked that her contact info be shared on the record to ensure arrangements would not fall through the cracks. She provided the phone number of 541-942-2286 for P. Cathey's residence in Cottage Grove, OR as well as 541-485-6659 for Andreason's Cremation & Burial Services in Springfield, OR, the local entity with whom she is working. Chair Kilbourn reported that K. Blanchard would be calling Andreason's and that she would follow up to confirm that a monument is ordered in accordance with P. Cathey's wishes. She added that another employee she spoke with at Blanchard Family Funeral Home was unaware that the request for placement at the Clay Street Cemetery had been approved by the Commission in 2024.

c) Update on Elks Plot Information

Chair Kilbourn stated that she did not want to tackle two items at the same time with K. Blanchard and thus did not ask him about the missing flash drive that is said to contain a wealth of information about placement of individuals in the Elk's section of the cemetery. She shared that J. Jones had conveyed that a high-level official at the Elks Lodge had heard that K. Blanchard had recently found the flash drive. She discussed how valuable this information would be to the Commission's ongoing work.

NEW BUSINESS

a) Digital Migration of CSC Information, Website ArcGIS Integration, & AR App Creation – Long-Term Project Proposal

Chair Kilbourn invited J. Desmond to share details about the project proposal she had prepared.

J. Desmond gave a brief summary of her hope to see a digital resource created to allow individuals to learn more about those who are buried at the cemetery. **Chair Kilbourn** asked if she was aware of the weekly walks conducted by staff at the Morris Thompson Cultural and Visitor's Center and the printed materials about the cemetery that are made available to visitors. **J. Desmond** indicated that she was but

would like to see more information available through a website. **Chair Kilbourn** described the information available through the free website Find a Grave and outlined the hundreds of hours of work that has been spent by the commission over the years, primarily by J. Richardson, to enter details for individuals who are at Clay Street Cemetery. She noted that J. Richardson continually monitors this platform to ensure the information stays accurate. She pointed out that interactive websites and applications can be very expensive, with the one in Juneau costing around \$29,000. **Chair Kilbourn** explained that their primary project is installing markers for every gravesite at the property, with research to gather all necessary data. She indicated that there is unlikely anyone on the Commission with time available to devote to this project unless J. Desmond was intending to take it on herself.

- **A. Stratman** concurred with Chair Kilbourn's summary but acknowledged that the project was not a bad idea to have on their radar for future years. **Chair Kilbourn** reiterated that her main focus is the 90 markers to be placed in the summer of 2025. **A. Stratman** agreed that the marker placement tasks are very difficult. She discussed the volume of work that goes into the research side of the Commission's efforts.
- **J. Desmond** explained that her hope was to have a searchable database of the information gathered over the years but also a website presence that focused on the cemetery itself. **Chair Kilbourn** discussed how everything they have researched is available on Find a Grave. **A. Stratman** agreed that the platform has been a great way for each of them to record what they have found over the years, although there is always the concern that a random person can still submit unverified information to an individual's profile.
- **J. Desmond** asked if it would be possible to have a link to Find a Grave on the City website. **C. Chase** indicated that this would be possible. He gave a description of plans for upgrades with the City's website, particularly the Boards and Commissions section, in the near future. **A. Stratman** stated that this would likely result in more public awareness and participation for things related to the cemetery. **J. Desmond** agreed that it would increase visibility, which was one of her goals.
- **J. Richardson** shared that the kiosk at the cemetery has a wealth of information and directs interested visitors to Find a Grave for more details on many individuals buried there. She confirmed that she has personally spent thousands of hours cleaning up data on the website, including writing short biographies. She reported that she is the manager of about 90% of the profiles for people buried at Clay Street with listings on Find a Grave. **J. Richardson** added that she can link the person's profile to other family members and attach documents or references to other genealogical databases as citations. **C. Chase** asked if each person's profile has an individual link that could be shared. **J. Richardson** confirmed that they do.
- C. Chase suggested that the City website could include a higher quality pdf map of the cemetery which had been created by the City Surveyor and shows each grave marker's plot number. He explained that each number be hyperlinked to that person's profile on Find a Grave. J. Richardson shared that Find a Grave does not allow outside links to be used within an individual's listing. C. Chase clarified that it would actually be links in the pdf taking people to Find a Grave.
- **J. Richardson** provided a summary of the large scope of tasks they have undertaken at the cemetery over the last few years, including the project to mark every gravesite with a flag and plot number so the City Surveyor could use GPS technology to log the exact coordinates of every single grave. She explained that this, along with ground-penetrating radar work, allowed them to update maps that had been unchanged since 1963. She reported that in past years, the Commission would only install between 10 and 30 markers each summer but in recent years they have increased that to around 150. **J. Richardson** discussed the toll

this takes on them physically in their summer working months and mentally during the research phase in winter. She shared that herself, Chair Kilbourn, and A. Stratman, via their membership in the Fairbanks Genealogical Society, host a cemetery walk and history tour every year in May. She noted that she would like to update the brochure they currently stock at the Morris Thompson Cultural and Visitor's Center.

- J. Desmond acknowledged that this was only her second meeting as a Commission member and thanked J. Richardson for sharing details of their work over the last several years. She suggested that if the brochure is updated, she would love to see it posted on the City website. Chair Kilbourn stated that they had been told in the past that they were unable to have things uploaded to the City website. C. Chase indicated that there is a way to have a dedicated page for these kinds of materials added to an appropriate location online. Chair Kilbourn stated that she would forward him the most current version of the brochure.
- **J. Richardson** added that each summer they also put in extra time to help clear weeds away from the cemetery's markers, using their own weedwhackers. **Chair Kilbourn** concurred that while some supplies and materials are covered by the Commission's bank account, they each often pay for things with personal funds. She explained to J. Desmond that if she was interested in pursuing the project to create a digital reference tool as had been discussed, she was welcome to do so but noted that all other Commission members would have their hands full for the foreseeable future with their other tasks of research, marker placement, public engagement, and maintaining the property. **A. Stratman** agreed that she was not able to add anything more to her plate but would be happy to share what she has gathered over the years.
- **J. Desmond** stated that she was also interested in helping with the physical labor aspect of the marker placement work come summertime. She shared that she is also a member of a local Rotary group that she would be happy to recruit for additional volunteer needs. **Chair Kilbourn** shared details about their annual cleanup day in May and their regular schedule for workdays throughout the summer. **J. Desmond** stated that she has an upcoming Rotary meeting and would start to put feelers out for extra help.

OPEN AGENDA

J. Richardson shared that a few days prior she had sent a letter to the Pioneers of Alaska Foundation requesting funds to purchase gravel to raise the sunken markers in their section of the cemetery. She noted that the Foundation's next meeting will be on Friday.
