WHEREAS, the successful responsive bidder for the project is Exclusive Paving. Inc. of Fairbanks, Alaska; and

WHEREAS, funding for this project is provided to the City of Fairbanks through the State of Alaska Department of Transportation & Public Facilities as directed by FMATS, from local companies for certain betterments, and from capital and general funds for the IT project: and

WHEREAS, the City of Fairbanks will maintain the improvements, and there is no City of Fairbanks match requirement for the construction of this project;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Fairbanks,

SECTION 1. That the Bid by Exclusive Paving, Inc. in the amount of Nine Million, Five Hundred Fifty-Eight Thousand Dollars and Fifty Cents (\$9,558,000.50) is hereby approved for award.

SECTION 2. That the Mayor is hereby authorized to execute a contract and such other documents in a form approved by the City Attorney as may be necessary to effect award of the contract.

SECTION 3. This award is contingent upon FMATS approving \$799,266.00 in funding for the project.
