PARCEL ONE:

A certain lot or parcel of land lying in said Woodstock and on the easterly side of the road leading from Bryant Pond Village in said Woodstock to Pinhook, so called, also in said Woodstock, bounded as follows: Easterly by land of Cullen Abbott, now or formerly; southerly by land now or formerly of E.P. Lovejoy, formerly the Albion P. Cole Homestead; westerly by land now or formerly of James M. Day; northerly by land now or formerly of Antti Korhonen, formerly the Newell Rowe Homestead, and said real estate is westerly half of Lot eighty-one (81) in the west part of said Woodstock. Also conveying all right title and interest in the common boundary line deed of Cleo T. Billings (formerly Cleo T. Kerns) to Sterling A. Mills and Irene H. Mills, dated February 5, 1986, recorded in Volume 1372, Page 243 in the Oxford County Registry of Deeds; Excepting all right title and interest in the common boundary line deed of Sterling A. Mills to Irene H. Mills to Cleo T. Billings (formerly Cleo T. Kerns), dated February 6, 1986, recorded in Volume 1372, Page 244 Oxford County Registry of Deeds.

J. Kinderman; thence South 70° West six hundred seven feet and two inches (607' 2") to a corner marked by an iron pipe driven into the ground, thence North 28° west ninety-nine (99) feet to a corner marked by an iron pipe driven into the ground: thence in a course due west one hundred seventy-eight (178) feet to a point on the easterly boundary line of said Rumford Avenue; thence in a northerly direction on

and along the easterly boundary line of said Rumford Avenue eight hundred five (805) feet, more or less, to the point of beginning.
