You may recall that last May, when we received results showing that water from 54 of our fountains or faucets tested above the new Maine State Standard of 4 parts per billion (ppb), we immediately put a plan in place to stop students and staff from drinking water from any of those fountains/faucets. We then retested water from all 54 along with several others to determine if replacing the fixtures was the likely solution or if there were other areas of concern that needed to be investigated. The second set of test results showed the number of fountains/faucets needing to be replaced had been reduced to about 30. However, based on our water consultant's advice, we decided to replace more fixtures and pieces of equipment.

At this point, I want to re-emphasize that the Maine Drinking Water Program along with the Maine and US Depts of Environmental Protection have assured us that washing hands in water with lead levels above the "new" state standard would not be harmful to personal health.

The work on replacing the equipment, with the exception for two water fountain/filling stations, was completed before Thanksgiving. The remaining work will be completed in December. The details are as follows:

We now must retest each piece of new equipment to ensure that we have, indeed, fixed the problem. Currently, the required sampling bottles are not easily available anywhere in the country, so we are one of many districts on a waiting list for these containers. Until we can retest and receive acceptable results, we cannot use those fixtures replaced. We will continue, where necessary, to supply water to RSU 9 students and staff.
