 - The cost of food is high, such as citrus and romaine lettuce (three times as high as he has ever seen). We are able to get what we need, and we make substitutions as needed. The location of food sources varies greatly; in season we try to do as much locally as we can through our local vendors.
 - Reimbursement rates did increase this year, but not at the rate that labor and food are rising. A second round of Federal Relief Supply Funds from USDA will be sent to assist in each state. We will get some assistance from these to help defray costs.
