### 2. Previous Committee Minutes <u>1-2-2024</u>

  - i. None
- 3. 24-25 & beyond Student-Staff Tech Upgrades Kevin Bremner
  - a. Kevin reviewed the slideshow noting options for the RSU #9 Tech Upgrade (laptops, hybrid, iPads). There are varied financial implications with each model and few curriculum implications. iPads and laptops have similar capabilities. We want to stay Apple because of all of the software support and quality of machines. The two biggest concerns
    - i. We need to have a direction and plan moving forward as we can't keep discussing what the plan is for next year based on possible funding as it wastes time, energy, and is not a systemic, long-term solution.
  - b. Next steps
    - i. The presentation was for informational purposes for both committees.
    - ii. A recommendation will be made as part of the budget process. If we save \$150,000, it can equal two staff members.
  - c. Questions/Comments
    - i. What is being used beyond high school?
      - 1. This varies in the workforce.
      - 2. What about capabilities?
        - a. There was much follow up and a very lively discussion on these two points with varied opinions.
      - 3. Will there be a concern with staff and students if we go totally iPad?
        - a. Students will adapt.
        - b. Staff would have both devices and extra training support until the following refresh in the transition.

- 4. What will happen K-5?
  - a. Allocations will stay the same. K-4 is 2 students:1iPad. Those devices have been purchased and are not leased.

#### 4. Updates

- a. Nutrition Grant Elkington
  - i. Approved to keep moving forward with the grant.
  - ii. Not sure what we will do if we are approved as there are varied considerations for proper implementation.
- b. BARR Funding Poulin
  - i. The state is now able to fully fund coaching for year 2.
  - ii. Feedback and some initial data is positive with the work completed so far this year.
  - iii. We got in at a perfect time to receive the second year of funding as the state is not funding new schools in 2024-2025

#### 5. Presentations:

- a. Math (MBMS) Black/Duchesne
  - i. Textbook change
    - 1. Why?
      - a. MBMS has not had a consistent resource for math for many years and has had quite a bit of turnover in staff so the purchase of a highly research-based text was important.
      - b. They started reviewing resources and collaborated with MBHS/MBC on the selection of a resource. Reveal Math will allow for consistency in programming, delivery, and is aligned to CCSS. Teachers are more easily able to differentiate for all students.
      - 2. 1st semester progress
        - a. Teachers feel that they are on track with pacing. It has been user friendly with many ready to use resources.

#### 6. Grants

a. Connectivity Hub - Franklin - Director Mary Redmond-Luce

#### i. Review

- 1. This is a grant connected to the funding of a building.
- The intention is to find a place that is more accessible with multi-faceted outcomes to include workforce development, Adult Education and telemedicine. Having all resources in a central location is at the foundation of the request.
- 3. Digital literacy is vital to our community, and our county has recently increased access but needs some training. This project will assist with that goal.
- 4. The feedback from Board Members was incredibly strong.
- 5. As an aside, a move would free up space for MBHS and FCTEC.

- 6. We will know by May, 2024 if the grant is funded. We would need to move into the building by August, 2026.

- b. RFA First Ten Community Grant Poulin
  - i. <u>Application</u>
    - a. The application focuses on CCHS as an extension of the Community Schools grant.
    - b. There will be three years of funding.
    - c. A position will be funded to look at the opportunities to expand what we now do.
    - d. This would be an opportunity to expand our knowledge base and build capacity both at CCHS and within RSU 9
