#### 3. Presentations:

- a. <u>Curriculum Cycle Plan</u> Poulin
  - Assistant Super Poulin reviewed the Curriculum Cycle Plan document and the steps needed to be put in place to align RSU 9 work around a five year curriculum plan. Starting with Science & SS this summer as they are the first curriculum cycle ready per state work. The draft plan shares steps to bring back several similar structures from RSU 9's previous curriculum committee structure. Unfortunately, this district work and process fell by the wayside the last 5-7 years as district admin were pulled in other directions.
  - Reviewed the planning for both Horizontal and Vertical structures to improve staff understanding and support for all staff, ultimately supporting all students.
  - Lots of good questions about developing learning, curriculum, and the need for classroom and grade level measuring of student growth.
  - Systemic alignment is the aspirational piece with this plan.
  - The committee approved the plan 5-0!
- b. SEL Principal Smith
  - i. Have been working as an SEL committee this year to ensure that all staff have exposure to PD and therefore can incorporate aspects into our daily lessons. It does not need to be forced work with students or staff.
  - ii. BARR aligns perfectly with the CASEL wheel.
  - iii. Staff meetings have also included some SEL structures this year.
  - iv. SEL also aligns with some of our evaluation elements.
  - v. The SEL team is working on an SEL playbook (will be a digital platform) that we hope to release in the fall.
  - vi. We have allowed for choice in teacher PD in this area.
  - vii. Our SEL committee has recently expanded to over a dozen people!

- viii. Retention and attendance can be impacted by activities like "Optimistic Closure".
- ix. Social-emotional concerns ripple throughout our schools.

## 4. Homeschool Survey - Elkington

- a. Draft
  - We plan to reach out to our homeschooled families to get input if they are willing to share. There are financial implications to the high number of homeschooled students in our district.
  - ii. There was a suggestion to add a more general response (narrative) to the end of the survey.
  - iii. There are some political aspects to this work which we need to understand.
  - iv. We have a system and are now keeping good track of this information and will continue to dig into the numbers and to the why.
  - v. RSU #9 has made a concerted effort to ensure that families complete their paperwork as required by statute.
  - vi. Homeschool associations are working more closely together in support of each other.

# 5. USDA Rural Utilities Service (RUS) Distance Learning and Telemedicine (DLT) Grant Program

  - i. We would like to collaborate with Winthrop and RSU #44 to write a grant in support of our reducing iPads and interactive video equipment costs. The three tech directors are interested in moving forward. This will cost \$10,000 (split among the three districts) to write the grant. The funds are distributed based on what each district is seeking.
  - ii. There was a related discussion regarding iPads vs. laptops as part of the budget process, with support shared for high schools students having laptops. COsts are the concern and there was a suggestion that we could also offer PCs or Chromebooks instead of the "Mercedes Benz" of laptops by Apple. There was also a question regarding whether or not staff had been surveyed.
