  - b. Insurance came in at 8.9% which is 2% higher than we had hoped.The District Office went through the budget again and we have

located funds from interest yielding accounts that will cover the 2% that was not budgeted for the health insurance increase.

- c. Tonight's handout-overall budget-no changes; therefore, shares of each town remain the same.
- d. Fund balance forward is 3.1% percent currently, but we will know best based on the audit, not to exceed 5%.
- e. Teacher Evaluation Program-Why has the figure increased?
  - This was due to an increase in a new employee's salary & benefits and the addition of the Teacher Coaches stipends to support new teachers that was left out of the present budget.
