- A. Chair Robinson shared that the Grades 5-8 Regional Band performance was incredible and enjoyable.
- B. Cascade Brook School GATE Program was celebrated for being chosen as a state award winner.

A. A recently transferred to homeschool student spoke about school safety concerns.

VIII. Superintendent's Report - Elkington

- A. New Hires, Transfers, Resignations, and Retirements
 - 1. There was a question about reasons for leaving the district, which was addressed by Superintendent Elkington.
- B. No Committee Meetings In May
- C. First Ten Community School Pilot
 - 1. \$125,000 over 2.5 years
 - To support students in the first 10 years of their life partnering with a community organization. This will involve PD and programming.
 CCHS Staff will be meeting this Thursday with the MDOE for further details.
- D. All Maine Students Get Free Lunch: What does that mean for Poverty Data?
 - 1. What data are we using?
 - a) The state is using direct certification information for Title Grants. This will be used as part of the EPS formula calculation instead of using F/R lunch numbers. Students receiving state and federal assistance will be added to the list going forward.
 - 2. Is there any move to use the cost of housing as a piece of the economically disadvantaged numbers? We do not believe so. There have been conversations with the Maine delegation with regards to school funding as the poverty levels for differing areas around the country can be skewed because of the state's minimum wage level.

IX. Administrator Reports

- A. Special Services John Jones
 - 1. John highlighted a few points

- a) Unified Basketball-the second season was wonderful. Bocce is on the horizon this spring.
- b) Victoria Peterson was awarded a speech and language services award.
- c) John is retiring this year with appreciation to the board for their support.
- d) He will have an advisory meeting prior to his retirement.
- e) 399 students identified and 53 in referral-How does this compare to 5 years ago? A little bit lower, but there is an increase in the severity of need. This number has been relatively consistent over time.

B. MBHS Athletics - Cynthia Pratt

- 1. Many accomplishments this year, but most proud of how our athletes represented themselves.
- 2. This is the third consecutive year that the nordic boys' and girls' teams won the state championships. This year, they were also the sportsmanship award winners!

C. School Nutrition - Andy Hutchins

- Highlight-Student volunteering at CCHS culinary program once a week. They will be enrolled in the Culinary Program at FTC next year.
- 2. Culinary Skills training There will be three week-long workshops around the state this summer, and we were selected to host one. Twenty five people will participate, and we will have four slots.

D. <u>CBS</u> - Nichole Goodspeed

- 1. Nichole also shared the good news about the GATE students.
- 2. One Turtle's Lost Straw won March Madness Book Competition.
- 3. Leadership Teams have been working on culture and collaboration which has evolved into celebratory monthly assemblies.

E. FCTEC - Melissa Williams

- 1. Melissa highlighted the awesome adults at MBC and all the collaboration on campus.
- 2. Liz Leclair was invited to speak at a conference in RI for Great Schools Partnership around SEL in CTE classrooms.
- 3. Melissa shared some information regarding the Perkins Grant and thanked those completing the related needs assessment.
- 4. There was a question about the numbers in the report and who was included. Full tech students equal 405; this does not include exploratory students.

F. Transportation - Richard Joseph

1. Shared appreciation for the support staff team he has.

- 2. Bruce Rollins who is out on leave was well supported by his colleagues a few weeks ago.
- 3. Zonar props This is the device that prompts safety checks around the bus before and after each trip, including a student check at the end.
- 4. Little blue dots Allows the Bus Garage to track speed checks, student stops, and give excellent tracking in real time.
- 5. Question Do we have the second longest bus routes of any district in the state? Likely, 45 minutes is the average.

- "This budget is well crafted and not inflated; it is making a long-term commitment to our students when they first enter Public School to give them the best base for future success that we can. If it does not pass, concerns were shared about where cuts might land. It is not inflated and there is no excess to cut."
- It was noted that there was a request to administrators for needs and then wants. The budget reflects a good balance of this.
- "The budget was presented in a clearer fashion than in the past, which was appreciated."
- "This budget considers a lot of varied needs across the district for students, staff and families."

B. Field/Turf Sub Committee

- 1. Draft
 - a) This was discussed at the Operations Committee meeting.
 - b) Discussion: The board was the intended audience for this document. Wanted to get the information down on paper. There was feedback that this document appears premature and that there is a need to further discuss the direction that will be taken. The board reserved the right at the time of the initial vote to determine the direction of next steps for the field and this was further reviewed at another meeting. There was a request to have a committee to review the pros and cons and this document sets that up. Feelings shared was that this committee should start with the pros and cons of the synthetic field, and then report back to the board. The proposed committee includes a variety of individuals representing differing viewpoints. Concern was shared about needing more balance and for outside input from experts. We should also have a public health professional on this committee. We care about student health, and we should consider all potential impacts of a synthetic field.
 - c) The board took a vote to move forward with the synthetic field plan, and it passed.
 - d) Other Comments:
 - (1) This has been discussed for the past three years. The vote was overwhelmingly in support and is currently frustrating for the Boosters.

- (2) This is a way to move forward. If you read the vision, the committee will investigate the best materials. We can re vote if the information is clear that the health and safety of our students will be impacted.
- (3) There are three basic options no action, repair what we have, or adopt an artificial surface.
- (4) The proposed committee should look at all options, dig into the science and present all options to the full board.
- (5) This is a large undertaking and so it should be assigned to this committee for efficiency's sake, not the full board.
- (6) There are pros and cons each way. Overall, our board has leaned toward an artificial surface.
- (7) All but one school in our conference uses an artificial surface, and we should dig into the specifics.
- e) There was a concern shared about the safety of artificial turf and a request to have health officials speak, weigh in.
 - (1) It sounds like a done deal, and it should be further researched.
- f) We need to make an informed decision, and there are a few steps to take prior to that decision.
 - (1) Were these concerns raised when putting in the track? Are there safety concerns there as well?
- g) There was a motion to approve the committee and elect the board members who have currently served. (Wayne Kinney)
- h) There was a suggestion that we should have a committee approved with a different focus, to research the product.
- i) A specific list of health and safety/health research based concerns was shared with the committee. It was also shared that they were not certain we agreed to any particular timeline.
- j) We need to approve a committee to do the research, speak to the experts and bring that information to the full board.
 - (1) Will the committee make decisions on majority rule or consensus? How will they function? That will be decided by the committee.
 - (2) If this will be a majority report, it seems that this is a done deal given the present members on the committee.

- (3) Moving an artificial surface plan forward was decided by a previous vote.
- (4) We have gone way off track. If we want further discussion or have other members, we can do that.
