  - a. Called to order at 5:00.

  - a. Work progress
    - i. FY 25 Operations & Building Projects
      - 1. Review
        - a. Some projects have been moved to FY26. This was determined based on priorities and funding available. None of the deferred items are safety issues. MBC cameras will need to be replaced due to age and compatibility issues.
      - 2. District-wide winter heating/leak issues
        - a. Were reviewed
      - 3. Hydrant flushing took place over the April break.
      - 4. District mowing has begun.
      - 5. Gearing up for summer projects.
  - b. Preventative Maintenance contract for 25-26
    - i. Update
      - 1. When starting?
        - a. HVAC-Speciality Services-Starts in July.
  - c. 10 Yr Planning Committee
    - i. Progress?

1. They have been reviewing Sealander assessments-MBMS, GDC, and AHS. Will next review MBMS and dry system replacement on 5/14. Funding is set. Scott Madore from Sprinkler Systems believes soak and flush will find any issues and will be more cost effective. Although the quote says there are no leaking pipes covered, the company ensures us that there are. Will get written assurance from them. Next week, Scott Madore will join the group and will demonstrate what the process will be and what will be covered. Updated quote for soak and flush-\$67,700. It is recommended to have the vapor barrier in the pipes after the soak flush is completed.

  - 1. Pellets are used as the fuel. They are currently shut off. Speciality Services will be cleaning them.

# e. Buildings

- i. AHS/Cushing
  - 1. 24-25
    - a. Garden shed has been built! PTA helped to fund it with a grant and our people built it.
  - 2. 25-26
    - a. Sped Programming
      - Adaptive Skills program will be added. A bathroom will be included, but plumbing is already in place to access. A playground will be added with fencing.
- ii. Adult Ed
  - 1. Upgrades
    - a. Priorities-bathroom floor (completed over the break), entry door and window switch will be next. Future projects will include soundproofing in a couple of spaces, carpeting, hallway in the learning center, windows and a new door in her office. The roof is in good shape.
  - 2. Admin building life expectancy
    - a. Could be pushed to 8-10 years with some additional work

## iii. CBS

- 1. "Heath" Tree
  - a. Retiring this year-he has served 51 years in the district.
  - b. We hoped to plant a red maple tree, but since they are not allowed, we will be planting a Japanese Red Maple. It will be located next to the apple trees. We will also have a plaque honoring Steve.
  - c. Cleaned all heat pumps.

- 1. Leach field
  - a. Work completed?
    - Roads are still posted and so Taylor cannot make much progress. FCTEC is finishing up their work.

# v. Mallett

- Water heater
  - a. There is one domestic water heater for the entire building. It has had a hard time keeping up with the demands. It started leaking in February and is at the end of its life span. The quote is for \$45,000 for an LPG unit for efficiency. The propane vendor will supply the second tank.

- 1. Basement
  - a. Univents in locker rooms are almost complete.
  - b. Specialty Services replaced the pipes in the hallway. The last piece will be completed in June when school is out of session. Clean up will take place in July.

- Culinary space
  - a. Equipment delivered in two days. Need to make plans for installation.
