 - a. FY26 Budget
 - i. Additional funds (\$150,000 added at District Mtg.) review & discussion
 - 1. CE recommends only replacing 5th grade position at CBS at this time
 - 2. "New" Town Assessments
 - 3. Other possibilities TBD by the end of July
 - a. Would be based on possible move-ins increasing class size etc.
 - 4. Does the Board need to send this message out?
 - a. How?
 - Superintendent can share that in his memo to staff and community.
 - 5. Discussion
 - How much will we have left over if we fill one position? About half will remain.

- b. CE will come to the board with recommendations next week. These would be one year positions.
- c. Suggested that we wait as long as possible to make determinations.
- d. What will happen with federal funds? We have received Title I and are waiting on Title II and Title IV.
- e. Community members left thinking that we would be hiring two teachers. Superintendent did share that we would wait as long as possible to look at all school numbers. Committee agreed this makes sense moving forward. This allows the district the flexibility to make decisions based on data.
- f. Smaller schools make it more difficult to balance class size numbers.

b. 24-25 Monthly Budget Update

 - 1. Anticipated balance will likely be higher than we thought because of savings in special education.
 - 2. This summer, Special Education budget lines for the last three years will be reviewed to see if there is a pattern.
- iii. Special Ed Revenue
 - 1. System to bill MaineCare was slow to build, but it is gaining momentum with revenue reimbursement.
 - 2. Related, we received more funding last week through the formula for out of district placement.
